## Shawn Carruthers call the meeting to order and led the *Pledge of Allegiance*

### **New Business:**

- 1. Director of Operations and Planning-Don Lopp
  - a. Floyd County Resolution FCR 2020-09 Tax Sale Properties.

Motion to approve FCR 2020-09 Tax Sale Properties. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

- 2. Don Lopp stated that he needs signatures for Community Crossings Grant. It is a federal grant of \$50,000.00. Shawn Carruthers stated that the Commissioners, with Don's guidance, have started a program to support our local restaurants and local social service agencies. They purchased food from local restaurants and in turn take food to Hope Southern Indiana and Catalyst Rescue Mission. They also work with the Salvation Army. Once the Commissioners' money was used Don had applied for this grant to keep the program going.
- 3. Floyd County Commissioner Attorney Rick Fox

a. Rick Fox stated that he needed approval with a confidential privilege agreement with Clark and Floyd Counties and JTL concerning the landfill litigation. Ice Miller thought it prudent that we invoke with a doctrine which allows us to speak with regards to each of our interest without having to disclose to the other side to discovery so everyone is under the veil of attorney client privilege.

b. Rick Fox stated that there are two agreements with regards to the Jail Bond. There is a preference to use Reedy as opposed to Crowe. There is a provision with respect to contract termination in the Crowe agreement that allows either party to terminate the agreement with 90 days' notice.

Shawn Carruthers stated that they had signed an engagement letter on March 17, 2020 with Crowe to move forward with Jail Bonding but we already had an agreement with the Reedy Group.

Motion for Rick Fox to engage with Crowe to execute the termination clause. Moved by Tim Kamer. Seconded by John Schellenberger. Motion passed unanimously.
