Mary Brewer stated Vaccine Passport would create two classes of citizens based on someone's private medical records and decisions. She stated that, in her opinion, it should be up to the individual if they want to get the COVID vaccine. She requested the Commissioners to pass the Resolution.

Jackie Grubbs respectfully petitioned the Commissioners to pass the Resolution or Ordinance that would ban any type of vaccine passport in Floyd County, Indiana where it be an employer, business or any other institution. She stated several other counties in Indiana has passed resolutions.
