 a. 2<sup>nd</sup> FCO 2022-41 Creating a New Combined Highlander Fire Protection District

Diana Mayfield asked these questions;

How combining the districts would provide better service than what they are receiving now with two separate departments?

Why would combining the districts cost more to the taxpayers in one township and less to the other?

Why should she, as a taxpayer, believe that anything will be different as far as service?

What is the financial plan to ease taxpayers' burden in the future?

Reuben Cummings, GFC, works with Greenville and Lafayette Fire on budgeting and funding matters, stated the levies for the fire districts are the same but Lafayette Township's AV is 50% higher than the Greenville Township AV.

Attorney, John Kraft, stated Greenville Fire is under contract with Lafayette Fire. He reviewed the changes to the original ordinance stating the Commissioners will appoint one trustee from each township and one trustee from each municipality within the district, with a minimum of three trustees from Greenville Township and from Lafayette Township. There will be one atlarge appointment that will alternate between Greenville and Lafayette.

Shawn Carruthers stated by approving this ordinance this year they can build momentum on setting up the Fire district for 2024. If they wait until 2023 to pass this ordinance they will have to wait until 2025.

John Schellenberger stated both fire boards have done their due diligence. There are 12 board members that want this unanimously.

Motion to approve FCO 2022-41 Creating a New Combined Highlander Fire Protection District. Moved by John Schellenberger. Seconded by Shawn Carruthers. Motion passed.
