#### 2. AssuredPartners-Sandy Halstead

a. 2023 Humana Renewal Contract

Sandy Halstead reviewed the 2023 Humana Renewal Contract. The benefits will remain the same but the County will be self-insured instead of fully-insured for medical insurance. Humana Dental and Vision are on a two-year rate hold. The Life insurance will be provided by Standard instead of Unum. A flexible spending account will be offered.

#### 3. Kovert Hawkins-Larry Timperman

a. Safe Room Grant

Larry Timperman has been working with the Indiana Department of Homeland Security and FEMA on the development of FEMA safe rooms for public schools. It is a 75% and 25% matching grant. FEMA cover 75% of the cost and the school covers 25%. The safe rooms are designed to withstand 250 mph winds. The private schools are asking to be part of the process. Riverhills would be responsible for the process. The Commissioners need to approve the program.
