Al Knable called the meeting to order and led the Pledge of Allegiance

Present: President, Al Knable; Vice President, John Schellenberger and Jason Sharp **Also Present:** Attorney, Rick Fox; Sheriff, Steve Bush and Auditor, Diana Topping Al Knable led a moment of silence for prayer, meditation or reflection

New Business:

- 1. County Attorney-Rick Fox
 - a. FCR 2024-14 Approving Proposed Lease of New County Government Center Petition Approving Form

Brad Bingham of Barnes and Thornburg joined virtually to explain the process of obtaining the New County Government Center. The resolution establishes a nonprofit Building Corporation that would take on the debt from the purchase of the Chase property and then lease the building to the County. The next step is for the County Council to approve a resolution to approve the deal. If approved by Council, the Commissioners will have a public meeting and final vote to accept the Lease. The members of the Building Corporation Board are Todd Rosenbaum, Bill White and Tom Jones.

Motion to approve Floyd County Resolution 2024-14. Moved by John Schellenberger. Seconded by Jason Sharp. Motion passed unanimously.

- b. Lease Agreement
- c. FCO 2024-23 Revised Door-to-Door Solicitation Ordinance

Attorney, Rick Fox, stated modifications were made to a previously passed ordinance. Changes were made in the terms of jurisdiction of solicitation, deleted a redundant penalty. An identification card fee was added. Added harassing conduct and defined harassing conduct as a reason to revoke license. Added that a report from a complaint would not be provided if the complainant requested that their complaint not be provided to the company that was doing the solicitation.

Al Knable stated this comes from requests from property owners who instigated pushing this forward. It's a nice example of property owners speaking up and getting things done. Rick Fox said the ordinance will become effective after the two-week publication period. Motion to approve, with unanimous consent, Floyd County Ordinance 2024-23, an ordinance governing commercial door to door solicitation in Floyd County, Indiana. Moved by John Schellenberger. Seconded by Jason Sharp. Motion passed unanimously.

d. FCO 2024-24 Procedure to Replace an Appointed Fire Protection District Trustee

Rick Fox read the Ordinance into record. The Commissioners may replace an appointed trustee of the New Albany Township Fire Protection District, the Georgetown Township Fire Protection District or the Highlander Fire Protection District at their discretion, only upon a unanimous vote of the Floyd County Commissioners.

Motion to approve, with unanimous consent, Floyd County Ordinance 2024-24 Procedure to Replace an Appointed Fire Protection District Trustee. Moved by Jason Sharp. Seconded by John Schellenberger. Motion passed unanimously.

2. County Engineer-Horacio Urieta

- a. Change Order Altawood & Buffalo Trail Subdivision
 Horacio Urieta said the change order is for \$29,000.00.
 Motion to approve change order Altawood and Buffalo Trail. Moved by Jason Sharp.
 Seconded by John Schellenberger. Motion passed unanimously.
 - b. Change Order #1 Road Paving Project 2023 Community Crossing Second Round

Horacio Urieta said the change order is for an increase of approximately \$62,000.00. Motion to approve Change order #1-Road Paving Project 2023-Community Crossing-Second Round. Moved by John Schellenberger. Seconded by Jason Sharp. Motion passed unanimously.

3. Director of Building and Development-Nick Creevy

a. Safe Streets for All - Safety Committee

Nick Creevy stated this was part of a grant the we are co-applicants on with KIPDA. It's a planning grant for Safe Streets. The Committee consist of County Sheriff, County EMA Director, County Engineer, Highlander Fire, Georgetown Fire, New Albany Township Fire, School Corporation Representative and Representatives from Georgetown and Greenville. The first meeting was August 26.

b. FCO 2024-22 Map Amendments to Floyd County Zoning Ordinance-Tunnel Hill Nick Creevy stated the Floyd County Planning Commission provided a favorable recommendation on August 12 for the rezoning of two parcels off Tunnel Hill Road from Residential Urban to General Commercial.

Motion to approve, with unanimous consent, FCO 2024-22 Map Amendments to Floyd County Zoning Ordinance-Tunnel Hill. Moved by Jason Sharp. Seconded by John Schellenberger. Motion passed unanimously.

- c. Project Update for the Charlestown Road Trail

 Nick Creevy said there was a pre-construction meeting on August 29. It will be underway shortly. Flagging will start September 10. Excavation is expected to start about 2 weeks thereafter. Expected timeline for completion is end of Spring 2025. The construction is funded 100% from INDOT. The County is funding 10% for inspection.
 - d. Brookline Trail Extension Jensen Park

Nick Creevy said the contract is with All Terran Paving in the amount of \$21,860.00. It will be paid through Caesar Foundation money.

Motion to approve All Terrain Paving Construction for Brookline Trail Extension. Moved by John Schellenberger. Seconded by Jason Sharp. Motion passed unanimously.

e. Novaparke Labs AE -Contract

Nick Creevy said the contract is for Novaparke labs architecture and engineering with Tower Pinkster for IUS lab build out at Novaparke. The amount is \$44,000.00 Motion to approve. Moved by John Schellenberger. Seconded by Jason Sharp. Motion passed unanimously.

4. Thieneman Group-Don Thieneman

a. Plan of Action Building Inspector discussion

Mr. Thieneman was not present.

Nick Creevy said they have an inspector out for about 3 months for an emergency medical situation. The Building Commissioner has been doing double duty for plan reviews and inspections. They have reached out to neighboring jurisdictions to see if they could use some of their inspectors. Commissioner Sharp reached out to Jeffersonville's Commissioner. He is willing to assist but there is an issue with insurance that is a concern.

Rick Fox said they could hire him as an independent contractor, pay him more, buy the insurance and ask that we be named an additional insured on the policy or speaking to Glenn Smith and adding him to our policy.

5. FCR 2024-12 2025 Holiday Schedule

John Schellenberger stated since there are no elections next year there will be additional days for Independence Day and the day after Christmas.

Motion to approve. Moved by John Schellenberger. Seconded by Jason Sharp. Motion passed unanimously.

6. FCR 2024-13 2025 Commissioner Meeting Dates

7. Appointment to Highlander Fire Board Mike Zeller

Al Knable said three people interviewed for the position. John Schellenberger said there were three nominees, two were retired firefighters. One is experienced in the mining industry and his skill sets were primarily safety. Mike Zeller is retired from the Louisville Fire Department. The third applicant, Executive Assistant Chief, Katherine Clemmer he thinks is suburb for this position. She is an active firefight from Louisville with over 22 years' experience as a professional firefighter as Apparatus operator, Company Commander, Battalion Chief, Medical Officer and now Executive Assistant Chief. Highlander has 50 firefighters and EMS personnel, 10 are female. The current board is all male. 20% of the workforce are female and adding Assistant Chief Clemmer would provide diversity to the 9-member Board of Trustees. The other

two members could be considered down the road if another vacancy is available. He said her resume is stellar. He thinks they need to show the taxpayers and voters of this County that they need diversity. She is a very qualified candidate.

Jason Sharp asked if any of the female firefighter and EMS personnel work in Officer or Command level positions. He thinks she had a great resume and could be a great Chief candidate.

Al Knable stated all three individuals are very qualified. He thinks Mr. Zeller is the most qualified at this moment in time. The other two applicants said they would like to stay active in the applicant pool if another position becomes available.

Motion to approve the appointment of Mike Zeller to the Highlander Fire Board. Moved by Jason Sharp. Seconded by Al Knable. Motion passed 2-1. John Schellenberger opposed.
