Meeting Minutes Board of Commissioners September 17, 2024 6:00 P.M.

Al Knable called the Public Hearing to order.

Public Hearing:

Notice of Public Hearing on Proposed Lease Between The Floyd County, Indiana Building Corporation and Floyd County, Indiana

Thomas Everett of Barnes and Thornburg, said the lease was preliminarily approved by the Commissioners on September 3. A notice of Public Hearing on the lease was published and the statute requires that before taking final action to approve the lease, the Board of Commissioners hold a public hearing on the lease. The lease is to finance the acquisition, construction and renovation of the building to serve as the County's public offices for certain departments.

George Mouser, Phillip Schmidt Road, read a letter to the Commissioners expressing strong objections to the encumbering of the Floyd County taxpayers for 30 years. The three Floyd County Commissioners have demonstrated a lack of due diligence of their official responsibilities. He referenced Ordinance 2024-21 that states under definitions that it applies to the City of Fishers. He questioned why the error was not caught and corrected. He doesn't approve of the Building Corporation.

Al Knable said the Building Corporation members have been named and they do not receive a salary.

Thomas Moore, Georgetown Township, said he agrees with Mr. Mouser that the Commissioners do not do their due diligence when signing something based primarily upon the say so of a paid consultant. He said he only knew one Commissioner that personally reviewed payroll and claims. He also referred to the Hospital Sale was hurried.

He asked for honesty and transparency and put the project be put on a referendum and not creative financing.

Al Knable said at the last Joint Meeting with the Council the consensus was to rebuild but only if there's a referendum is a necessary part of that. In reference to due diligence, what the public sees in meetings is only a fraction of the review that takes place. The Commissioners get the documents several days in advance and reviewed in detail. In regards to why no excuse has been rendered for the Fishers, Indiana Ordinance is because he has no excuse. He did not catch the error.

Attorney, Rick Fox, said he drafted the Ordinance using an Ordinance from Fishers. When he caught the error, he redrafted the Ordinance before anyone knew about it and had on the table to be passed again at the next meeting.

Motion to adjourn the public Hearing. Moved by John Schellenberger. Seconded by Jason Sharp. Motion passed unanimously.

It also authorizes the Building Corporation to issue bond anticipation notes prior to the issuance of the bonds in the amount not to exceed \$10,500,000.00. It authorizes any member of the board and County Council to take any actions to complete the execution and delivery of the lease and the issuance of the bonds by the Building Corporation.

Mr. Everett stated the execution of the Resolution authorizes the execution of the lease. The Commissioners will sign and execute the lease at the end of the meeting.
