## **Public Comment**

John Manzo, 3016 Cobbler Crossing Road, New Albany, vice president of the HOA of Cobbler Crossing, spoke of damages from storms and inconveniences of the traffic on Charlestown Road and closing of Blackiston Mill Bridge. He said Lumos is damaging property extensively. A lot of the residents in the subdivision is feeling overwhelmed and under protected.

Al Knable said a couple of the neighborhoods that Lumos was in earlier sent pictures of the work that had been done by Lumos. Our County Engineer spoke to Lumos Engineers about the concerns. He asked Mr. Manzo to send pictures to him so they can speak to the Lumos folks to make sure they are doing what they are supposed to do within specification.

Jason Engle, 3305 Cobblers Court, New Albany, expressed his concerns with Lumos. They are digging without the utilities being marked. They are digging numerous holes but are not completing the process and leaving large holes throughout the neighborhood.

Al Knable said the Commissioners will look into it and suggested they speak to Senator, Gary Byrne or State Representatives.
