

An ordinance amending Ordinance No. A67-4 entitled "AN ORDINANCE CLASSIFYING, REGULATING AND RESTRICTING THE LOCATION, HEIGHT, AREA, BULK, AND USE OF BUILDINGS AND STRUCTURES AND THE USE OF LAND IN THE UNINCORPORATED TERRITORY OF FLOYD COUNTY, INDIANA."

Be it ordained by the Board of County Commissioners of Floyd County, Indiana, that the above ordinance be and the same is hereby amended as follows:

Section 1. That the real estate in Floyd County, Indiana, described in the attached memorandum be, and it is hereby changed from R-1 to R-4 Multi-family.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Board of County Commissioners of Floyd County, Indiana.

M E M O R A N D U M

All that part of Survey No. 62 of the Illinois Grant or Clarks Grant, thus bounded: Beginning at a point in the center of a public road, known as the Bald Knob Road or Klerner Lane which point is 637 feet southwest from a stake and stone near a small black oak corner of lands formerly owned by Martin Very and Lawson Very; running thence Southwest in the center of the public road, South Thirty-six and one-fourth degrees ( $36 \frac{1}{4}^{\circ}$ ) west, Eight Hundred and Sixty-seven and one-half ( $867 \frac{1}{2}$ ) feet to a stake; thence North thirty-two and one-half degrees ( $32 \frac{1}{2}^{\circ}$ ) West One Hundred and Forty-eight and one-half ( $148 \frac{1}{2}$ ) feet to a stone; thence North Seventeen and one-fourth degrees ( $17 \frac{1}{4}^{\circ}$ ) West Nine Hundred and Four (904) feet to a stake; thence North Fifty-four degrees ( $54^{\circ}$ ) East Eight Hundred and Seventy-one (871) feet to a stake; thence South Twenty-two and three-fourths degrees ( $22 \frac{3}{4}^{\circ}$ ) East Four Hundred and Eighty-five (485) feet to a stake in the public road; thence South Seventeen and one-half degrees ( $17 \frac{1}{2}^{\circ}$ ) East Five Hundred and Fifty-three (553) feet to the place of beginning; containing Twenty and eight-tenths (20.8) acres, more or less.

Excepting therefrom one (1) acre conveyed to Edwin G. Loebig and Louise C. Loebig, husband and wife, by deed dated April 21, 1965 and recorded April 22, 1965 in Deed Record 177 page 319 of the Floyd County, Indiana Records.
