

ORDINANCE NO. 77-3


AN ORDINANCE AMENDING ORDINANCE NO. 1967-2, AN ORDINANCE REGULATING  
THE INSTALLATION, CONSTRUCTION, MAINTENANCE AND OPERATION OF PRIVATE SEWAGE  
DISPOSAL SYSTEMS, DATED THE 4TH DAY OF SEPTEMBER, 1967

BE IT ORDAINED, by the Board of Commissioners of the County of Floyd, Indiana, under and pursuant to the authority of Chapter 80, Section 3, of the Acts of 1953, and all acts amendatory thereto of the General Assembly of the State of Indiana, and the provisions of Indiana Code, Section 17-2-22-3, that Ordinance No. 1967-2, an Ordinance regulating the installation, construction, maintenance, and operation of private sewage disposal systems, dated September 4, 1967, be and the same hereby is, amended by the deletion therefrom of Section 302 of Article III, and the substitution therefor of the following:


SECTION 302: Before commencement of construction of any building or private residence where a private sewage disposal system or privy is to be installed or where any alteration, repair, or addition of an existing private sewage disposal system is planned, the owner or agent of the owner shall first obtain a written permit signed by the County Health Officer. The application for such permit shall be made on a form provided by Floyd County, Indiana, which application shall state conformance with Section 206 of this Ordinance. The permit and inspection fee of \$10.00 shall be paid to the County Treasurer at the time the application is filed.
