AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF FLOYD, STATE OF INDIANA, ESTABLISHING THE FLOYD COUNTY SHERIFF'S POLICE RESERVES AND THEIR POWERS; SETTING FORTH THE PROCEDURE FOR APPOINTMENT, AND THE MAXIMUM NUMBER THAT MAY BE APPOINTED; AND PROVIDING FOR AN ALLOWANCE FOR UNIFORMS.

F C ORDINANCE #79-I 1979

BE IT ORDAINED by the Board of Commissioners of the County of Floyd, State of Indiana, under and pursuant to the authority delegated by the General Assemby of the State of Indiana, Acts 1975, P.L. 205: I.C. 19-1-17.5, including any subsequent amendments or changes thereto, that:

Part 1. POLICE RESERVES: ESTABLISHMENT, APPOINTMENT AND BENEFITS

SECTION 100: AUTHORITY

- (1) The Board of Commissioners of the County of Floyd, under and pursuant to the authority delegated by the General Assembly of the State of Indiana, Acts 1975, P.L. 205; I.C. 19-1-17.5, including any amendments thereto, do hereby adopt this Ordinance establishing the Floyd County Sheriff's Police Reserves.
- (2) It is hereby intended that Acts 1975, P.L. 205; I.C. 19-1-17.5 be hereby incorporated by reference and made a part hereof.

SECTION 101: ESTABLISHMENT

- (a) There is hereby created a position within the Floyd County Sheriff's Police Force to be known as the Floyd County Sheriff's Police Reserves, hereinafter referred to as "Police Reserves".
- (b) The number of Police Reserves shall not exceed seventy-five (75) persons.
- (c) Police Reserves shall not be members of the regular Floyd County Sheriff's Police Force, but Police Reserves shall have the same police powers as such regular members, except as such police powers may be limited by rules adopted and promulgated by the Floyd County Sheriff's Merit Board.
- (d) Service of Police Reserves shall be subject to those rules and regulations as may be hereafter adopted and promulgated by the Floyd County Sheriff's Merit Board.

SECTION 102: APPOINTMENT

- (a) Police Reserves shall be appointed by that authority which presently is or may hereafter be vested with the power to appoint regular members of the Floyd County Sheriff's Department.
- (b) No Police Reserve shall be appointed until the individual has completed such training program and probationary period as may be hereafter established pursuant to Section 101(d), hereof.

SECTION 103: BENEFITS AND COMPENSATION

- (a) Police Reserves shall not participate in any pension program which is provided for regular members of the Sheriff's Department, and shall not receive compensation except as may otherwise be provided in this section.
- (b) To the extent of appropriations by the Floyd County Council,
 Police Reserves may receive an allowance, payable semi-annually,
 for the purpose of defraying uniform cleaning costs, PROVIDED,
 that at the time of such semi-annual disbursement, a Police Reserve
 must be a current, scheduled member of the Floyd County Sheriff's
 Police Reserves and must have completed six (6) months of duty.
 - Part 2. SEVERABILITY, REPEAL, AND DATE OF EFFECT

SECTION 201: SEVERABILITY

If any clause, phrase, provision, or section of this Ordinance, or application thereof to any person or circumstance, shall be held invalid, such invalidity shall not affect or render void any other clause, phrase, provision, section or application of this Ordinance which can be given effect without the invalid part or application thereof. It is the intention of the Board of Commissioners of the County of Floyd in the adoption of this Ordinance to adopt each clause, phrase, provision, or section thereof separately, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION 202: REPEAL

All ordinances and parts of ordinances heretofore adopted which are in conflict with this Ordinance are hereby repealed.

SECTION 203: DATE OF EFFECT

This ordinance shall be in full force and effect upon its adoption and due publication as may be provided by law.
