

Section 3. Upon completion of all revisions to the Floyd County Zoning Ordinances Code as necessitated by this Comprehensive Plan, the Floyd County Master Plan as previously adopted and all amendments thereto are hereby repealed.

Section 4. This Ordinance shall be in full force and effect from and after its passage and approval by the Board of Commissioners of Floyd County, Indiana.

ORDINANCE NO. FCO 82-3

AN ORDINANCE TO ADOPT AND ENFORCE THE COMPREHENSIVE PLAN

An ordinance adopting and enforcing the "Floyd County Area Comprehensive Plan 2002", to-wit:

WHEREAS, on May 17, 1982, the Floyd County Plan Commission passed a resolution which adopted the document entitled "Floyd County Area Comprehensive Plan 2002" as the official Comprehensive Plan of Floyd County, Indiana; and

WHEREAS, said Plan is intended to take the place of Floyd County's original Master (Comprehensive) Plan adopted March 2, 1970, as amended, and provide the foundation for various mechanisms to implement it; and

WHEREAS, the Plan Commission has asked the Board of Commissioners of Floyd County to review its action and to adopt an ordinance for the enforcement of said Plan; and

WHEREAS, the Board of Commissioners of Floyd County has reviewed the document entitled "Floyd County Area Comprehensive Plan 2002" and has found it to be an acceptable policy for the future development of Floyd County; and

WHEREAS, the Board of Commissioners of Floyd County must now proceed to acknowledge the adoption of said Plan and establish and/or revise mechanisms for its enforcement;

THEREFORE, be it ordained by the Board of Commissioners of Floyd County, Indiana, pursuant to IC 36-7-4-509, in accordance with the recommendation of the Floyd County Plan Commission, that;

Section 1. The "Floyd County Area Comprehensive Plan 2002" dated May 17, 1982 is hereby adopted as the official Comprehensive Plan of the County of Floyd, Indiana.

Section 2. The Comprehensive Plan shall be used as the policy basis for future amendments to, or the creation of various regulatory mechanism for its enforcement, including the Floyd County Land Use Ordinances.
