CONTRACT

THIS AGREEMENT ENTERED INTO THIS 18th DAY OF FEBRUARY, 1992,
BETWEEN LELAND A. WATSON, SHERIFF OF FLOYD COUNTY, INDIANA, (SHERIFF)
AND ROOKIES AN INDIANA CORPORATION (CONTRACTOR).

IN CONSIDERATION OF THE SUM OF FIFTEEN THOUSAND, FOUR HUNDRED NINETY
TWO DOLLARS (\$15,492.00) FOR THE YEAR 1992, TO BE PAID BY SHERIFF TO
CONTRACTOR IN ONE THOUSAND FIVE HUNDRED FOURTY NINE DOLLARS EVERY MONTH
(\$1,549.00) FOR THE REMAINING MONTHS FOR 1992, CONTRACTOR AGREES TO
FURNISH AND BE RESPONSIBLE FOR ALL LABOR NECESSARY TO PREPARE AND SERVE
THREE (3) MEALS PER DAY, SEVEN (7) DAYS PER WEEK, TO ANY AND ALL PRISONERS
HOUSED IN THE FLOYD COUNTY , INDIANA, JAIL.

IT IS EXPRESSLY AGREED BETWEEN THE PARTIES THAT SHERIFF SHALL PROVIDE
ALL FOOD, SEASONINGS, UTENSILS, AND EQUIPMENT REASONABLE NECESSARY FOR
CONTRACTOR TO PERFORM THE TASK DESCRIBED ABOVE.

CONTRACTOR SHALL BE RESPONSIBLE FOR AND FURNISH ALL NECESSARY INSURANCE
FOR CONTRACTOR'S EMPLOYEES, INCLUDING, BUT NOT LIMITED TO, WORKMAN'S
COMPENSATION INSURANCE.

BOTH PARTIES HERETO EXPLICITLY AGREE AND STIPULATE THAT CONTRACTOR
IS AN INDEPENDENT CONTRACTOR AND LABORERS PROVIDED BY CONTRACTOR SHALL
BE DEEMED TO BE CONTRACTORS EMPLOYEES FOR ALL PURPOSES.

THIS CONTRACT IS NON-ASSIGNABLE AND MAY BE CANCELLED BY EITHER PARTY
BY NOTIFYING THE OTHER PARTY IN WRITING THIRTY (30) DAYS IN ADVANCE OF SAID
CANCELLATION.
