

FLOYD COUNTY ORDINANCE 1993-5

AN ORDINANCE AMENDING THE FLOYD COUNTY CAPITAL IMPROVEMENT PLAN

WHEREAS, by Floyd County Ordinance 1992-5, the Board of Commissioners of the County of Floyd duly adopted, pursuant to the provisions of I.C. 6-3.5-7-15, a Capital Improvement Plan encompassing the period from June 30, 1992 to December 31, 1994; and

WHEREAS, the Floyd County Capital Improvement Plan providing for the payment of lease-rentals becoming due the New Albany-Floyd County, Indiana Building Authority in connection with the construction of the Criminal Justice Facility was amended by Floyd County Ordinance 1993- ____ so as to permit the direct payment or reimbursement of certain costs and expenses incurred in connection with the construction or said Facility; and

WHEREAS, pursuant to an Inter-Local Agreement concluded by and between Floyd County, Indiana, and the Civil City of New Albany, Indiana, dated as of the ____ day of September, 1993, said agreement being incorporated herein by reference and made a part here of, certain emergency communication equipment is to be purchased and acquired in joint ownership by the City and County, situated within the Criminal Justice Facility; and utilized to provide communication services within and between fire and law enforcement agencies in Floyd County; and

WHEREAS, to fund said Inter-Local Agreement, the Board of Commissioners of the County of Floyd is desirous of amending the Floyd County Capital Improvement Plan to permit and allow the payments and reimbursements set forth in said Agreement to be paid from CEDIT revenues; and

WHEREAS, the Board of Commissioners of the County of Floyd is contemplating making certain improvements and modifications to the Floyd County Home so as to convert certain areas therein for use as office space for governmental agencies and entities; is desirous of funding the cost of such modifications and improvement with CEDIT revenues; and is desirous of amending the Floyd County Capital Improvement Plan to permit and allow such funding; and

WHEREAS, by Floyd County Resolutions 1993-10 and 11, the

Board of Commissioners of the County of Floyd defined two Economic Development Projects pursuant of the provisions of I.C. 6-3.5-7-13.1, and said Board is desirous of amending the Floyd County Capital Improvement Plan to permit and allow the funding of said projects from CEDIT revenues.

NOW THEREFORE:

BE IT ORDAINED, that the Floyd County Capital Improvement Plan dated the 16th day of June, 1992, as amended by Floyd County Ordinance 1993- _____ be, and the same hereby is, further amended and modified so as to permit the payment from CEDIT distributions of those expenses incurred by Floyd County in the purchase of equipment for the Criminal Justice Facility under and pursuant to that Interlocal Agreement concluded with the City of New Albany, Indiana, as of the _____ day of September, 1993, a copy of which Interlocal Agreement is incorporated herein by reference and made a part hereof.

BE IT FURTHER ORDAINED, that the Floyd County Capital Improvement Plan dated the 16th day of June, 1992, as amended, be further amended to permit the expenditure of \$25,000.00 of CEDIT revenues for improvements to and modifications of the Floyd County Home, which expenditure shall, however, be subject to appropriation by the Floyd County Council.

BE IT FURTHER ORDAINED, that the Floyd County Capital Improvement Plan, as amended, be further amended to reflect the expenditure of CEDIT revenues in furtherance of the Economic Development Projects established by Floyd County Resolutions 1993-10 and 11, with \$25,000.00 having been heretofore appropriated by the Floyd County Council for the project defined by FCR 1993-10 and the sum of \$80,000.00 having been appropriated for the project established by FCR 1993-11.

BE IT FURTHER ORDAINED, that two copies of the Floyd County Capital Improvement Plan, as amended by this Ordinance, shall be kept on file in the office of the Floyd County Auditor for public inspection.

BE IT FURTHER ORDAINED, that this ordinance shall be in full force and effect upon its passage.
