

FLOYD COUNTY ORDINANCE 1993- 8

AN ORDINANCE AMENDING THE FLOYD COUNTY CAPITAL IMPROVEMENT PLAN

WHEREAS, by Floyd County Ordinance 1992-5, the Board of Commissioners of the County of Floyd duly adopted, pursuant to the provisions of I.C. 6-3.5-7-15, a Capital Improvement Plan encompassing the period from June 30, 1992 to December 31, 1994; and

WHEREAS, the Floyd County Capital Improvement Plan providing for the payment of lease-rentals becoming due the New Albany-Floyd County, Indiana Building Authority in connection with the construction of the Criminal Justice Facility was amended by Floyd County Ordinance 1993- 3 so as to permit the direct payment or reimbursement of certain costs and expenses incurred in connection with the construction or said Facility; and

WHEREAS, the Floyd County Capital Improvement Plan was further amended by Floyd County Ordinance 1993- 5 to fund the and Interlocal Agreement with the Civil City of New Albany, Indiana; to provide funds for the improvement of the Floyd County Home; and, to confirm the expenditure of CEDIT revenues for Economic Development Projects previously defined by resolution of the Board of Commissioners of the County of Floyd; and

WHEREAS, by Floyd County Resolution 1993- 18, the Board of Commissioners of the County of Floyd has defined the humane control and disposal of stray animals within Floyd County as a project necessary to the economic development of the Floyd County, which resolution is incorporated herein by reference and made a part hereof; and

WHEREAS, the Board of Commissioners of the County of Floyd is desirous of further amending the Floyd County Economic Development Plan to fund the project defined by said resolution.

NOW THEREFORE:

BE IT ORDAINED, that the Floyd County Capital Improvement Plan dated the 16th day of June, 1992, as amended previously amended, be, and the same hereby is, further amended and modified so as to permit the payment from CEDIT

distributions of the sum of \$9,000.00 for the purchase of a new pickup truck for the Floyd County Animal Warden, such vehicle being necessary and appropriate for the performance of his duties and necessary for the accomplishment of the purposes set forth in Floyd County Resolution 1993- 18 .

BE IT FURTHER ORDAINED, that two copies of the Floyd County Capital Improvement Plan, as amended by this Ordinance, shall be kept on file in the office of the Floyd County Auditor for public inspection.

BE IT FURTHER ORDAINED, that this ordinance shall be in full force and effect upon its passage.
