

FLOYD COUNTY ORDINANCE FCO 95-9
ORDINANCE AMENDING FLOYD COUNTY ORDINANCE NO. FCO 95-8

WHEREAS, the Board of Commissioners of the County of Floyd adopted Ordinance No. 1981-1, which Ordinance, in part, established rates and charges for certain services to be provided by the New Albany-Floyd County Health Department, now known as the Floyd County Health Department, which are subsequently amended by Ordinance 1986-2, 1987-3, 1988-3, FCO 93-2, and FCO 95-8; and

WHEREAS, the Board of Commissioners of the County of Floyd is presently desirous of further amending said Ordinance as hereinafter set forth.

NOW, THEREFORE:

BE IT ORDAINED, that Floyd County Ordinance 1981-1, as amended by Floyd County Ordinance No. 1986-2, Floyd County Ordinance 1987-3, Floyd County Ordinance 1988-3, Floyd County Ordinance 1989-3, Floyd County Ordinance FCO 93-2, and Floyd County Ordinance FCO 95-8, be and the same hereby is further amended by the substitution for the rates and charges more particularly set forth in Exhibit "A" hereto, which Exhibit is incorporated herein by reference and made a part thereof.

BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect on and after the date of its adoption.
