

FLOYD COUNTY ORDINANCE- 1998-II  
AN ORDINANCE ALTERING THE BOUNDARIES OF CERTAIN VOTING  
PRECINCTS IN FLOYD COUNTY, INDIANA

WHEREAS, the Civil City of New Albany, Indiana, in Floyd County, Indiana, has annexed certain of the unincorporated areas of said county; and

WHEREAS, the provisions of I.C. 3-11-1.5-4 dictate that the Board of Commissioners of the County of Floyd alter the existing boundaries of certain voting precincts to recognize the annexation of territory by said city and the increased voting population in New Albany Township; and

WHEREAS, The Board of Commissioners of the County of Floyd has directed the Floyd County Engineer to prepare and file with the State Election Board descriptions, maps and summary sheets pertaining to the altered boundaries of certain voting precincts located in Floyd County, Indiana; and

WHEREAS, THE Board of Commissioners of the County of Floyd is desirous by this Ordinance of establishing the boundaries of certain voting precincts located in Floyd County, Indiana, all as hereinafter provided.

NOW THEREFORE:

BE IT ORDAINED, that the boundaries of the following precincts in the Civil City of New Albany, Indiana, and New Albany Township be, and they hereby are, established, altered or amended to conform with the descriptions, maps and summary sheets heretofore filed with the State Election Board, which maps, descriptions, and summary sheets are incorporated herein by reference and made a part of this Ordinance:

CITY OF NEW ALBANY

Precinct Number 28-A

NEW ALBANY TOWNSHIP

Precinct Number 31A

Precinct Number 34 A

Precinct Number 34

Precinct Number 34 B

BE IT FURTHER ORDAINED, that a copy of this Ordinance shall be filed with the State Election Board no later than seven days following its passage as required by the provisions of I.C. 3-11-1.5-14.

BE IT FURTHER ORDAINED, that this Ordinance shall be effective on the date specified by the State Election Board in its order approving this Ordinance in accordance with the provisions of I.C. 3-11-1.5-24, or, if no date is specified, then this Ordinance shall be effective upon the first date permitted under the provisions of I.C. 3-11-1.5-25.

BE IT FURTHER ORDAINED, that each of the altered precincts shall have polling places which comply with the accessibility requirement adopted by the State Election Board.
