

FLOYD COUNTY ORDINANCE 1998-VIII

AN ORDINANCE AMENDING THE FLOYD COUNTY CAPITAL IMPROVEMENT PLAN

WHEREAS, by Floyd County Ordinance 1996-___, the Board of Commissioners of the County of Floyd duly adopted, pursuant to the provisions of I.C. 6-3.5-7-15, a Capital Improvement Plan encompassing the period from January 1, 1997 to December 31, 1998; and

WHEREAS, by Floyd County Ordinance 1998-IV, the Board of Commissioners of the County of Floyd amended said Plan to permit the purchase of certain computer equipment; and

WHEREAS, the Board of Commissioners of the County of Floyd is desirous of repealing Floyd County Ordinance 1998-IV and substituting for the provisions thereof the amendments to said Capital Improvement Plan as hereinafter set forth.

NOW THEREFORE:

BE IT ORDAINED, that Floyd County Ordinance 1998-IV be, and the same hereby is repealed.

BE IT FURTHER ORDAINED, that the Floyd County Capital Improvement Plan dated the 1st day of January, 1997, as amended, be further amended to permit the expenditure CEDIT revenues in an amount not to exceed \$500,000.00, for the purchase, maintenance, repair, or replacement of computer hardware and/or software for judicial, non-judicial, and law enforcement agencies, offices, and departments of Floyd County, Indiana, to include an NCIC computer for the Floyd County Sheriff's office, which expenditures shall, however, be subject to appropriation by the Floyd County Council.

BE IT FURTHER ORDAINED, that the Floyd County Capital Improvement Plan dated the 1st day of January, 1997, as amended, be further amended to permit the expenditure of not more than \$75,000.00 of CEDIT revenues for the purchase of computer hardware and/or software for the office of the Floyd County Recorder, which expenditure shall, however, be subject to appropriation by the Floyd County Council.

BE IT FURTHER ORDAINED that the Floyd County Capital Improvement Plan date the 1st day of January, 1997, as amended, be further amended to permit the expenditure of

\$20,000.00 for the payments of fees and charges incurred in the preparation of a feasibility study and other services rendered in connection with the possible formation of a regional sewer district encompassing portions of Floyd County, Indiana.

BE IT FURTHER ORDAINED, that two copies of the Floyd County Capital Improvement Plan, as amended by this Ordinance, shall be kept on file in the office of the Floyd County Auditor for public inspection.

BE IT FURTHER ORDAINED, that this ordinance shall be in full force and effect upon its passage.
