

FLOYD COUNTY ORDINANCE 2005- I I

AN ORDINANCE APPROPRIATING EMERGENCY TELEPHONE SYSTEM FUNDS

WHEREAS, pursuant to the provisions of IC 36-8-16, *et seq.*, the Floyd County Council has established a uniform enhanced emergency telephone system fee, which fees, upon receipt, are deposited by the Floyd County Auditor in the Floyd County Emergency Telephone System Fund (Fund); and

WHEREAS, the Civil City of New Albany, Indiana (City), has petitioned the Board of Commissioners of the County of Floyd (Board) for an appropriation from the Fund to enable the purchase equipment, furniture, fixtures, services, and supplies necessary to equip the newly constructed Emergency Dispatch Facility (Facility) located in said city so as to facilitate the dispatch of its fire departments, police officers, and emergency ambulance services, all as contemplated by cited statute; and

WHEREAS, the Board has determined that the requested equipment, furniture, fixtures, services and supplies will constitute a necessary part of the emergency telephone system of Floyd County, Indiana; that the purchase and funding of same is authorized by the provisions of IC 36-8-16-14; and, that the purchase of such equipment is consistent with the audit position of the state board of accounts; and

WHEREAS, the Board is presently desirous of approving the request of the City, appropriating the necessary funds, and authorizing the City to proceed with the purchase of equipment in accordance with IC 5-22-8, *et seq.*

NOW THEREFORE:

BE IT ORDAINED, that the recitals set forth herein be, and the same hereby are, incorporated into this ordinance and made a part hereof.

BE IT ORDAINED, pursuant to the authority of IC 36-8-16-4, that a sum not to exceed \$536,000.00 be, and the same hereby is, appropriated from the Floyd County Emergency Telephone System Fund for the use by the Civil City of New Albany, Indiana, to purchase and acquire equipment, furniture, fixtures, services, and supplies necessary to equip the Facility of new equipment which will be used to dispatch emergency response units and vehicles within said City.

BE IT FURTHER ORDAINED, that the appropriated funds shall be used solely for the purchase and acquisition of such equipment, furniture, fixtures, services, and supplies as specifically authorized and permitted by the provisions of IC 36-8-16, *et seq.*, and that all purchases shall be made in accordance with the provisions of IC 5-22-8, *et seq.*, or other applicable statute, rule, or

regulation, if any.

BE IT FURTHER ORDAINED, that all property and equipment purchased and installed pursuant to this appropriation and ordinance shall be and remain the property of Floyd County, Indiana, unless otherwise so ordered.
