# FCO 2009-VI ORDINANCE NO.

## AN ORDER ESTABLISHING AN ANNUAL SEX OR VIOLENT OFFENDER REGISTRATION FEE, A SEX OR VIOLENT OFFENDER ADDRESS CHANGE FEE, AND ESTABLISHING THE FLOYD COUNTY SEX OR VIOLENT OFFENDER ADMINISTRATION FUND

WHEREAS, the Board of Commissioners of Floyd County, Indiana ("Commissioners") is the executive and legislative body for Floyd County;

WHEREAS, subject to the provisions of I.C. § 36-2-13-5.6, the Commissioners may require the Floyd County Sheriff to collect an annual sex or violent offender registration fee and a sex or violent offender address change fee; and,

WHEREAS, the Commissioners desire to establish the Floyd County Sex or Violent Offender Administration Fund to fund the administration of the sex or violent offender registration system.

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of Floyd County, Indiana that the sex or violent offender registration fee, sex or violent offender address change fee, and the Floyd County Sex or Violent Offender Administration Fund are hereby established, as follows:

#### Establishment of Sex or Violent Offender Administration Fund. Section 1.

The Floyd County Sex or Violent Offender Administration Fund is hereby established. The purpose of the fund is to defray the expense of administering or ensuring compliance with the laws concerning the Indiana Sex and Violent Offender Registry.

#### Section 2. Fees.

Registration Fee. The annual fee for sex and violent offenders registering a. in Floyd County shall be Fifty Dollars (\$50.00). Payment of the fee shall be made upon the offender's initial registration in Floyd County and subsequently on or before each annual registration date.

b. <u>Change of Address Fee</u>. A fee of Five Dollars (\$5.00) shall be charged and collected each time a sex or violent offender registers an address change with the Floyd County Sheriff's Office.

## Section 3. Payment of Fees.

All fees collected under this ordinance shall be collected by the Floyd County Sheriff's Office when a sex or violent offender registers with the Floyd County Sheriff's Office.

### Section 4. Procedures.

All fees collected under this Ordinance by the Floyd County Sheriff's Office shall be transferred to the Floyd County Auditor in a timely manner. On a monthly basis, the Floyd County Auditor shall:

- (a) Deposit ninety percent (90%) of any fees collected under this Ordinance in the Floyd County Sex and Violent Administration Fund; and
- (b) Transfer ten percent (10%) of any fees collected under this Ordinance to the State of Indiana for deposit in the State Sex and Violent Offender Administration Fund under I.C. 11-8-8-21.

## Section 5. Administration of fund.

A county fiscal body shall appropriate money from the county sex offender registry fund to offset or defray any administrative costs that may occur while handling the state law regarding sex offenders.
