AN ORDINANCE VACATING A PUBLIC WAY

AN ORDINANCE FOR THE VACATION OF THE PUBLIC WAY PURSUANT TO A
PETITION FILED BY DONNA M. STASER

BE IT ORDAINED by the Board of Commissioners of Floyd County, Indiana, pursuant to I.C. 36-7-3-12, that:


SECTION 1. The application filed by DONNA M. STASER, is requesting the vacation of a portion of the public way described as follows and being in the County of Floyd, State of Indiana, to-wit:

AN EXTENSION OF HIGH STREET COMMENCING AT THE RIGHT-OF-WAY OF FEATHERINGILL ROAD (FORMERLY THIRD CROSS STREET) AND SPLITTING PLATS 135 AND 132 OF THE FLOYD COUNTY, INDIANA RECORDS AND CONTINUING 240 FEET IN A WESTERLY DIRECTION.

SECTION 2. That the vacation shall not affect governmental rights to those areas designated as flood ways, flood plains, and/or flood ponding areas.

SECTION 3. This Ordinance vacating the above-described property in Floyd County, Indiana shall be in the full force and effect from and after its passage by the Board of Commissioners of the County of Floyd, State of Indiana, this 19th day of October, 2010, subject to verification of the legal description of the Floyd County Surveyor.

PETITION TO VACATE ALLEYWAYS AND PUBLIC WAYS

COMES NOW DONNA M. STASER and after being duly sworn upon her oath and states:

1. That she is the owner of real estate situate in the County of Floyd, State of Indiana, more specifically described as follows, to-wit:

LOTS NOS. 61, 62 AND 63 ON HIGH STREET IN SEASES PLAT OF GERMANTOWN (NOW GALENA) BEING NO. 132 OF THE FLOYD COUNTY, INDIANA RECORDS.

ALSO, LOTS 1, 2 AND 3 IN PARKS FIRST ADDITION TO SAID TOWN OF GALENA, SAME BEIGN PLAT NO. 135 OF THE FLOYD COUNTY, INDIANA RECORDS.

ALSO, A FRACTIONAL LOT ADJOINING SAID LOT NO. 1 ON THE WEST SIDE THEREOF, SAME EXTENDING 120 FEET FROM HIGH STREET.

ALSO BEING LOT NO. FOUR (4) ON HIGH STREET IN ISAAC PARK'S FIRST ADDITION TO THE TOWN OF GERMANTOWN, A PLAT OF SAID ADDITION IS REFERRED TO IN THE RECORDER'S OFFICE OF FLOYD COUNTY, INDIANA, SAID LOT BEING 60 EET FRONT AND REAR AND EXTENDING BACK 120 FEET AND BEING IN PLAT NO. 135 OF THE FLOYD COUNTY, INDIANA RECORDS CALLED PARK'S ADDITION TO THE TOWN OF GALENA IN 1837.

and took title to the same with her husband, ROGER L. STASER, who died September 30, 1982.

2. That dividing the above tracts of real estate are certain streets and/or roadways and/or alleyways, which limit the Petitioner's use of said real estate, and are presently unimproved and do not serve anyone other than the Petitioner herein.

3. That the alleys/roadways to be vacated are more specifically described in the attached "Exhibit A".

5. That the name and address of the owner of land that is nearest and abutting the real estate to be vacated are shown in the attached "Exhibit B".

WHEREFORE, Petitioner requests the vacation of those alleyways/unimproved roadways described herein, pursuant to I.C. 36-7-3-12, and all other proper relief in the premises.
