AN ORDINANCE ESTABLISHING BUILDING SECURITY UNDER THE FLOYD COUNTY SHERIFF

WHEREAS, the Board of Commissioners of the County of Floyd, has elected to implement building security to benefit the safety of the general public, employees, and elected officials that conduct business in the New Albany City / County Building.

WHEREAS, the Board of Commissioners of the County of Floyd will give all authority to the Sheriff of Floyd County to administer and enforce the policies, ordinances, and procedures set forth in the attached policy "New Albany City County Building Security Policy" adopted by the Floyd County Commissioners. The authority included but not limited to access control systems, duress alarms, security camera monitoring, and implementation of the security policy and procedures.

NOW THEREFORE:

BE IT ORDAINED, that employees that work in the New Albany City / County building will be governed by the "New Albany City / County Building Security Policy" attached, and be granted employee access as defined in the policy.

BE IT ORDAINED, that the financial responsibility will we be as follows

- a. <u>STAFFING</u> The Floyd County Sheriff and the New Albany Building Authority will enter into a contract for security services provided on a yearly basis. The Sheriff shall retain full authority over his/her employees and services provided according to contract.
- b. <u>EQUIPMENT</u> The Floyd County Sheriff shall be responsible for supplying and maintaining appropriate security measures / equipment.

BE IT ORDAINED, that the Floyd County Sheriff, may collect fees for private entity access cards in the amount of \$50.00 per year. Private entity access cards are defined as private parties such as private firm attorneys, vendors, and other private parties who may apply for access cards with the Sheriff by application. The approval of the access card system will be at the discretion of the Sheriff. The funds collected for these private entity access cards will be placed in a non-reverting fund to which it may be used in the following manner:

- 1. Repairs, improvements, or implementation of existing or new security equipment.
- 2. Yearly fees for the security systems maintenance agreements.
- 3. Staff uniform expenses or training related to court security.

BE IT ORDAINED, that the Floyd County, Indiana, the New Albany City / County Building Security Policy can be changed by resolution by the Floyd County Commissioners.

BE IT ORDAINED, that this Ordinance shall be in full force and effect upon passage, and two copies of this Ordinance will be forwarded to the following legislative bodies: New Albany – Floyd County Building Authority, Floyd County Council, New City Council, and Floyd County Sheriff's Department.
