## THE BOARD OF COMMISSIONERS OF THE COUNTY OF FLOYD FLOYD COUNTY ON-SITE WASTEWATER MANAGEMENT DISTRICT

Whereas, the Board of Commissioners of the County of Floyd, by the power vested to it pursuant to the Indiana Constitution and provisions of law enacted by the general assembly and codified into legislation by the State of Indiana hereby state as follows:

Whereas, the Floyd County Commissioners wish to retain the rural character for the residents of rural Floyd County.

Whereas, Indiana law provides for the creation of an On-Site Sewage Disposal District pursuant to IC 36-11-3-1 Sec.1(a),

Whereas, Indiana law provides for the use of residential on-site sewage systems pursuant to 410 IAC 6-8.3,

Whereas, the City of New Albany has passed an ordinance that allows for expansion of its municipal sewer system to extend four (4) miles into the unincorporated area of the county of Floyd, (See map.)

Whereas, the Town of Georgetown has agreed to allow for expansion of its municipal sewer system into an area of the unincorporated county of Floyd, (See map.)

Whereas, the Floyd County Board of Health is vested with the responsibility of management of on-site sewage systems pursuant to 410 IAC 6-8.3,

### NOW THEREFORE:

BE IT ORDAINED that the Board of Commissioners of the County of Floyd hereby establish an ON-SITE SEWAGE DISPOSAL DISTRICT that shall comprise any and all land or real property located within Floyd County that is not currently a legally-established sewer district or that is not controlled, restricted, or otherwise already governed for the purpose of sewage disposal and/or treatment by a legitimate declaration of authority by a Certificate of Territorial Authority (CTA) or by extension of its sewer district by an officially recognized and incorporated municipal entity (i.e., town or city) as of this date, May 7, 2014.





In addition to the map showing the Wymberly Woods WWTP expansion area, the map showing the Chimneywood WWTP that has merged with Wymberly Woods, and the map showing the agreed area between New Albany and Georgetown, these are the areas of Floyd County that would also be excluded from an On-Site District:

- 1. Deerwood Environmental WWTP located in Floyds Knobs and provides service to the Woods of Lafayette Subdivision and a small surrounding area.
- 2. Heritage Springs WWTP located in the Town of Greenville and presently serves only the Heritage Springs Subdivisioin.
- 3. A WWTP that serves Floyd Central High School and Highland Hills Middle School.
- 4. A WWTP that serves Greenville Elementary School.
- 5. A WWTP that serves Floyds Knobs Elementary School.

# AN ORDINANCE PERMITTING FORMER AND RETIRED SHERIFFS TO CARRY POLICE FIREARMS

WHEREAS, Ind. Code § 35-47-11.1-4 allows local governments to enact and enforce regulations pertaining to firearms, ammunition, or firearm accessories issued to or used by law enforcement officers in the course of their official duties, and

**WHEREAS**, Floyd County has resolved and determined that it is in the public interest to allow its former and retired sheriffs to be permitted to keep and use their police firearms,

### IT IS THEREFORE ORDAINED that:

- 1. Former and retired sheriffs of Floyd County are hereby allowed to retain their police handguns, and reasonable replacements for their police handguns, for their personal use and to carry without further permits or other applications.
- 2. This Ordinance does not operate to allow any person to carry a firearm if they are otherwise prohibited from carrying the same by any Federal, state, or other law.

#### CERTIFICATE OF TERRITORIAL AUTHORITY NO. 162

### Chimney Wood Sewage Works, Inc.

PUBLIC SERVICE COMMISSION OF INDIANA, acting under and pursuant to the powers conferred upon it in and by Section 97C of the Public Service Commission Act, and pursuant to Order entered by the Commission on October 7, 1981, in Cause No. 36468, pending before it, hereby issues and grants unto Chimney Wood Sewage Works, Inc., an Indiana Corporation, a Certificate of Territorial Authority authorizing the rendering of sewage disposal service within rural areas located in Floyd County, Indiana, and more particularly described as follows:

Commencing at a stone at the northeast corner of the Northeast Quarter of Section No. 24, Township 2 South, Range 5 East and running thence N. 89 deg. 57' 27" W. along the north line of said Section No. 24, a distance of 1333.26' to the true place of beginning of land to be herein described:

Thence S. 1 deg. 46' 32" E., 1565.76'; thence S. 71 deg. 08' 45" W., 441.82'; thence S. 1 deg. 46' 32" E., 184.52' to a railroad spike in the center of the Luther Road, a county road; thence N. 81 deg. 46' 07" W. along said road centerline, 508.29'; thence N. 0 deg. 03' 29" W., 1820.09'; thence S. 89 deg. 57'27" E., 868.74' to the place of beginning and containing 36.0749 acres of land.

in which rural areas public convenience and necessity require the rendering of the sewage disposal service hereby authorized.

This Certificate of Territorial Authority is issued, and is to be held and used, subject to the applicable terms, conditions and provisions of the Public Service Commission Act, as amended from time to time, promulgated by the Commission.
