**AN ORDINANCE ESTABLISHING COLLECTIVE BARGAINING  
FOR THE FLOYD COUNTY SHERIFF'S DEPARTMENT, CORRECTIONS DIVISION**

WHEREAS, the Floyd County Commissioners, the Floyd County Council, the Sheriff of Floyd County, and the Floyd County Corrections Bargaining Committee desire to create and maintain an environment of cooperation and understanding with the corrections employees of the Floyd County Sheriff's Department.

WHEREAS, the Floyd County Commissioners, the Floyd County Council, the Sheriff of Floyd County, and the Floyd County Corrections Bargaining Committee wish to set forth in writing the salaries, wages, hours and conditions of employment for the corrections employees of the Floyd County Sheriff's Department; and

WHEREAS, the Floyd County Commissioners, the Floyd County Council, the Sheriff of Floyd County, and the Floyd County Corrections Bargaining Committee wish to be able to bargain in good faith without impasse arbitration but with recognized bargaining representatives and agent of said corrections employees; and

WHEREAS, the interests of the citizens of Floyd County and the Floyd County Sheriff's Department will be well served by good faith bargaining with the corrections employees of the Floyd County Sheriff's Department.

NOW THEREFORE:

BE IT ORDAINED, that it is the desire and deemed necessary to recognize the elected members of the Floyd County Corrections Bargaining Committee, as the sole and exclusive bargaining agent for the purpose of establishing salaries, wages, hours and conditions of employment for all corrections employees without, however, impasse arbitration. The Sheriff and his Jail Commanders are excluded from this ordinance. The "**Bargaining Committee**" shall include three (3) Corrections Officers who have been selected by a majority vote of all Corrections Officers to serve as representatives in negotiations or grievance issues relating to this contract or any future contract with the Employer. The County Commissioners shall appoint one (1) member to the Bargaining


Committee as The County Council shall appoint two (2) members to the Bargaining Committee. The members of the Bargaining Committee shall serve in this capacity until such time as their successors are duly elected. The Bargaining Committee shall set regular meeting dates after the organizational meeting each year.


BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect upon passage, and two (2) copies of this ordinance shall be forwarded to the Floyd County Auditor and the Secretary of State of Indiana.

RESOLUTION FOR ADOPTION  
BY THE BOARD OF COUNTY COMMISSIONERS  
OF FLOYD COUNTY, INDIANA

BE IT RESOLVED that this body hold a joint meeting with the Common Council of the City of New Albany, Indiana, and with the County Council of Floyd County, Indiana, and at said meeting hold a public hearing on and consider the creation of the "New Albany, Floyd County, Indiana Building Authority", all as provided in the Engrossed Senate Bill No. 69, as approved March 3, 1953, and which is designated as Chapter 54 of the 1953 Acys of the Indiana General Assembly.

BE IT FURTHER RESOLVED that the said meeting and public hearing be held in the Circuit Court Room in the Court House of Floyd County, at New Albany, Indiana, on the 11th day of August, 1953, at 10:00 o'clock A. M., and that the presiding officer of this body be given authority to notify the Auditor of Floyd County, Indiana, of the passage of this resolution and the time and place of said meeting and public hearing.
