

FLOYD COUNTY RESOLUTION NO. 80- 7

WHEREAS, the Town of Greenville, Floyd County, Indiana, has made its application to the United States of America, Farmers Home Administration, for a loan totaling \$350,000.00, such loan being for the purpose of the improvement and the expansion of the water facility owned and operated by said Town; and

WHEREAS, the contemplated expansion project includes the installation of water lines and mains as more particularly set forth on the right of way map heretofore submitted to the Floyd County Engineer for his examination and review; and

WHEREAS, the Town of Greenville, Floyd County, Indiana, contemplates the acquisition of private right of ways for the purpose of the installation of those water mains and lines shown upon said right of way map, which right of way shall parallel certain roads or highways under the jurisdiction of the Board of Commissioners of the County of Floyd, namely, Old Vincennes Road, Alonzo Smith Road, Buck Creek Road, Payton Road, and the Georgetown-Greenville Road; and

WHEREAS, the Town of Greenville is desirous of obtaining the concurrence of the Board of Commissioners of the County of Floyd for the use of existing county roadways for the installation of necessary water lines and mains in connection with the proposed expansion project, which right of ways would be used only in those instances where it was not feasible or possible to acquire necessary private right of ways for such purposes, the use of which right of ways to be under such reasonable terms and conditions as may be suggested and required by the Board of Commissioners of the County of Floyd; and

WHEREAS, the Board of Commissioners of the County of Floyd having reviewed the proposed expansion project is desirous of evidencing its concurrence with the use of such existing right of ways by the Town of Greenville, Floyd County, Indiana, in connection with such project.


NOW THEREFORE:


BE IT RESOLVED, that the Town Board of Greenville, Floyd County, Indiana, be, and said Board is hereby authorized to use existing right of ways under the jurisdiction of the Board of Commissioners of the County of Floyd for the purpose of the installation, maintenance and operation of necessary water mains and lines in connection with the existing expansion project undertaken by said Town Board, such use to be in accordance with the reasonable requirements established by this Board or the Floyd County Engineer.


BE IT FURTHER RESOLVED, that in the event that it shall be necessary to cross any county road for the purpose of the installation of such water mains and lines, that such crossing be made only with the prior authorization of this Board, acting by and through the Floyd County Engineer, with such crossing to be made under such conditions as may be deemed reasonable and necessary to protect such roadways.
