RESOLUTION NO. FCR 94-V11

RESOLUTION OF THE COUNTY COMMISSIONERS OF
THE COUNTY OF FLOYD, INDIANA
AUTHORIZING THE SUBMITTAL OF THE HOUSING DEVELOPMENT FUND APPLICATION
TO THE INDIANA HOUSING FINANCE AUTHORITY
AND ADDRESSING RELATED MATTERS

WHEREAS, The Floyd County Board of Commissioners, Floyd County, Indiana recognizes the need to stimulate growth and to maintain affordable housing within its corporate limits; and

WHEREAS, the Housing and Community Development Act of 1974, as amended, authorizes the Indiana Housing Finance Authority to provide grants to local units of government to meet the affordable housing and community development needs of low and moderate income persons; and

WHEREAS, the Floyd County Board of Commissioners, Floyd County, Indiana has conducted or will conduct public hearings prior to the submission of an application to the Indiana Housing Finance Authority, said public hearings to assess the housing, public facilities and economic needs of its low and moderate income residents;

NOW THEREFORE, BE IT RESOLVED, by the Floyd County Board of Commissioners, Floyd County, Indiana that;

1. The Floyd County Board of Commissioners authorizes Hoosier Valley Economic Opportunity Corporation to prepare and submit an application for grant funding to address the permanent housing needs of low and moderate income families in Floyd County, Indiana, and to execute and administer a resultant grant including agreements pursuant to regulations of the Indiana Housing Finance Authority and the United States Department of Housing and Urban Development.
2. That Hoosier Valley Economic Opportunity Corporation will serve as the subrecipient and administer the grant as provided for through Public Law 100 specifying that Community Action Agencies are allowed enter into Interlocal Agreements with local units of government. This agreement will be executed in accordance with the law.
