WHEREAS, the Board of Commissioners of the County of Floyd, to assist the District in meeting its financial obligations and to avoid the necessity of imposing a property tax upon the residents of Floyd County for District purposes, is desirous of granting funds to the District pursuant to the provisions of I.C. 13-9.5-2-11.7.

NOW THEREFORE:



SO RESOLVED, this 15th day of December, 1998.


