## Floyd County Board Of Commissioners Resolution 1999

FCR 99-II

Whereas, the city of New Albany currently owns one (1) 1986 Ford Ambulance (Vin# 2FDKF37GCA88552); and

Whereas, The city of New Albany has no further use for the Ambulance and desires to transfer ownerhip of the Ambulance to Floyd County, Indiana, for the use of the Sheriff in Fulfilling the duties of his office; and

Whereas, Floyd County, Indiana, currently owns one (1) 1983 Chevy Step Van (vin # 1GBJP32JXD3315677); and

Whereas, Floyd County, Indiana has no forth use for said Step Van, and Desires to transfer ownership of same to the City of New Albany; and

Whereas, Such transfers between governmental entities is authorized by Indiana Code 36-1-11-8 providing substantially identical resolutions are passed by each entity; and

Whereas, The Floyd County transfers the Van and will accept transfer of the ambulance subject to the specific conditions set forth below.

Now Therefore, Be it resolved that the Floyd County Board of Commissioners authorize the Sheriff Of Floyd County to proceed with the transfer of the Step Van to the City Of New Albany upon the following terms and conditions:

- 1. In exchange for one (1) 1983 Chevy Step Van (vin# 1GBJP32JXD3315677), The County of Floyd agrees to accept the transfer of ownership of the 1986 Ford ambulance (vin #2FDKF37GCA88552). The Sheriff agrees to pay all costs associated with the transfer of the ambulance, including but not limited to, the costs of transferring the title.
- 2. The City of New Albany will transfer the ambulance and Floyd County will accept the ambulance "AS IS". The City of New Albany will disclaim all warranties including implied warranties of merchantability and fitness for a particular purpose.
- 3. The County of Floyd will transfer the 1983 Step Van "AS IS". The County Of Floyd disclaims all warranties including implied warranties of merchantability and fitness for a particular purpose.

- 4. Floyd County shall indemnify and hold harmless the City of New Albany and it's officers, agents, or employees, from any and all claims or threats of claims, costs, losses, liabilities, judgements, or liens arising out of or in any way connected with its ownership or use of the ambulance, including but not limited to any claims arising as a result of this transaction by any Federal, State or local government agency.
- 5. The City shall agree to imdemnify and hold harmless the Sheriff and the County Of Floyd and it's agents, or employees, from any and all claims or threats of claims, costs, losses, liabilities, judgements, or liens arising out of or in any way connected with its ownership or use of the Step Van, including but not limited to any claims arising as a result of this transaction by any Federal, State or local government agency.
- 6. Floyd County warrants that it is a governmental entity as defined by Indiana Code #36-1-11-8.
