# A RESOLUTION AMENDING THE PROPOSED COMPREHENSIVE PLAN

WHEREAS, the Floyd County Plan Commission did, at its regular meeting held on the 19th day of July, 1999, approve a new Comprehensive Plan for Floyd County, Indiana, all as permitted and required by the provisions of IC 36-7-4-508(a); and

WHEREAS, the approved final draft of said plan, the same being entitled the 1997-99 Comprehensive Plan Update dated the 10th day of March, 1999, together with: (1) a Sanitary Sewer Service Areas Map, (2) a Thoroughfare Map, (3) an Existing Land Use Map, (4) a Floodway and Steep Slopes Map, and (5) the 1992-2012 version of the Comprehensive Plan Map, have been duly certified to the Board of Commissioners of the County of Floyd pursuant to the provisions of IC 36-7-4-508(b) by correspondence dated the 20th day of July, 1999; and

WHEREAS, the Board of Commissioners of the County of Floyd, designated by the provisions of IC 36-1-2-9 as being the "legislative body" for Floyd County, Indiana, after due consideration of the final draft of said Comprehensive Plan and the maps forming a part of same, now finds that the same should be amended as permitted by the provisions of IC 36-7-4-510(a) and returned to the Floyd County Plan Commission for such action, if any, as it shall deem appropriate pursuant to the provisions of IC 36-7-4-510(b).

WHEREAS, the Board of Commissioners of the County of Floyd. designated by the provisions of IC 36-1-2-9 as being the "legislative body" for Floyd County. Indiana, after due consideration of the final draft of said Comprehensive Plan and the maps forming a part of same, now finds that the same should be amended as permitted by the provisions of IC 36-7-4-510(a) and returned to the Floyd County Plan Commission for such action. If any, as it shall deem appropriate pursuant to the provisions of IC 36-7-4-510(b).

#### NOW THEREPORE:

BE IT RESOLVED, the proposed 1999 Floyd County Comprehensive Flan (hereinafter "Comprehensive Plan"), being composed of the final draft of the 1997-99 Comprehensive Plan Endate which is dated the 10th day of March, 1999, together with the Collowing designated maps:

- (1) Sanitary Sever Service Areas Map
  - (2) Thoroughfare Man
  - (3) Existing Land Use Map
  - (4) Floodway and Steep Slopes Map
- (5) 1992-2012 version of the Comprehensive Plan Map

be, and said proposed 1999 Comprehensive Plan hereby is, amended in the Collewing particulars:

- a. The 1992-2012 version of the Comprehensive Plan Map is deleted from the 1999 Floyd County Comprehensive Plan.
- b. From the Policy Statement number 1 appearing on page 5 of the final draft, the following subparagraph is deleted: g. public school system, and the remaining subparagraphs are relettered as appropriate.
- c. From Policy Statement number 7 appearing on page 7 of the final draft, the following language is deleted: "and social infrastructure (fire protection, law enforcement, public schools).
- d. In Objective 1.1 of Goal 1 and in subparagraph 3 of the Implementation provisions for said Objective, all appearing on page 9 of the final draft, the word "should" is substituted for the word "shall.
- e. In Objective 1.3 of Goal 1 appearing on page 10 of the final draft, the phrase "not intrude" is deleted and the phrase "minimize intrusion" is substituted therefor.
- f. In subparagraph 2 of the Implementation provisions of Objective 1.3 appearing on page 10 of the final draft, the phrase "Whenever possible" is added to the beginning of said subparagraph.
- g. In paragraph 1 of the implementation provision pertaining to Objective 3.1 of Goal 3 appearing on page 12 of the final draft, the phrase "including the school system" is deleted.
- h. In the last paragraph appearing on page 38 of the final draft, the phrase "wastewater policy" is repeated and one of the repeated phrases is deleted.
- i. In the statement of Mr. Bill Fender appearing on page 71 of the final draft, the phrase "Highlander Point" in the last line is changed to read "Highlander Village".
- j. The materials appearing in the final draft following page 39 shall be deemed an Appendix to the Comprehensive Plan; an appropriate divider shall be inserted; and the Table of Contents of the Plan shall be modified as appropriate to reflect such division.

BE IT FURTHER RESOLVED, that the 1999 Floyd County Comprehensive Plan, as amended in the foregoing particulars, be returned to the Floyd County Plan Commission, pursuant to the provisions of IC 36-7-4-510(a), for such action, if any, as it shall deem necessary and appropriate pursuant to the provision of IC 36-7-4-510(b).
