#### PROJECT PRIORITY RANKING SYSTEM

# **Priority A**

Project must be considered a priority to the community's economic well being or quality of life by the local unit of government that has jurisdiction over the benefiting area. The project must be considered *crucial* in nature and include one of the following criteria:

- 1. Represent a constraint to economic development
- 2. Constitute a serious threat to the health, safety, well-being or quality of life of affected residents
- 3. Respond to a serious economic, social or fiscal threat or problem.

### **Priority B**

Projects must be a community priority which are *important* but not *crucial* as described above (Priority A), or are crucial but do not appear feasible due to financial, physical, environmental or other constraints.

# **Priority C**

Projects that are considered desirable by the community, are a secondary priority or otherwise do not meet the criteria of Priority A or Priority B.
