FLOYD COUNTY RESOLUTION 2001- IX

A RESOLUTION PERTAINING TO THE COMPENSATION OF CERTAIN EMPLOYEES OF ON ACTIVE DUTY AS A MEMBER OF THE INDIANA NATIONAL GUARD OR A RESERVE COMPONENT

WHEREAS, following the terrorist attacks of September 11, 2001, certain national guard, militia, and reserve units of the various states have been activated; and

WHEREAS, it is anticipated that certain employees of Floyd County, Indiana, may be called to state active duty pursuant to the provisions of IC 10-2-4-4, or other applicable statute, rule, or regulation; and

WHEREAS, while a leave of absence for such active duty is mandated pursuant to the provisions of IC 10-2-4-3, the continuation of an employee's pay and benefits remains within the discretion of the employer; and

WHEREAS, the Board of Commissioners of the County of Floyd is desirous, with the concurrence and consent of the Floyd County Council, of promulgating a rule on such subject to be applicable during this period of crisis.

NOW THEREFORE:

BE IT RESOLVED, that full-time county employees called to and reporting for state active military duty, pursuant to the provisions of IC 10-2-2-4, shall receive as compensation from Floyd County, Indiana, during the term of the leave of absence mandated by IC 10-2-4-3, a sum equal to the difference between the employee's regular county pay and the military pay (including dependent allowances, if any) received by the employee during the term of such leave, PROVIDED, that in the event such military pay exceeds an employee's regular county compensation, no payment shall be made.

BE IT FURTHER RESOLVED, that during such mandated leave of absence, an employee shall be entitled to continue to participate in those benefit programs provided under Section 4 of the <u>Floyd County</u>, <u>Indiana</u>, <u>Employee Handbook</u> or otherwise, to the same extent as if such employee remained in full-time status with Floyd County, Indiana.
