Dear Commissioners,

It has come to my attention that there does not appear to be any official action by the Floyd County Commissioners that can be found wherein the Commissioners approved the name that has been used for over 21 years: Floyd Memorial Hospital and Health Services.

The only record of a name change that can be found is the attached Resolution the Floyd County Commissioners passed in 1985, changing the name from *Memorial Hospital of Floyd County* to *Floyd Memorial Hospital*. Apparently, sometime in 1992 the hospital changed its name to Floyd Memorial Hospital and Health Services, without official action of the Commissioners. Even if such action were taken in 1992, current records do not reflect it.

Due to the historic use of the name and certain legal questions that I have been confronted with regarding the proper name of the Hospital, I would respectfully request that at your next meeting you take official action to formally change the name in Floyd County's records to:
