RESOLUTION OF THE BOARD OF COMMISSIONERS OF FLOYD COUNTY, INDIANA**

WHEREAS: THE SHERIFF is a law enforcement agency for Floyd County, Indiana responsible to protect and serve our community with professional service, implement technology to combat crime, and keep our public and staff safe and,


WHEREAS: Floyd County Community Corrections (FCCC) is responsible for the supervision of individuals in our community to enhance public safety, reduce repeat crimes and help improve lives by applying evidence-based practices and validated assessments to reduce barriers, target criminogenic needs through effective interventions, and build individual self-efficacy to sustain change and become productive members of the community and,

WHEREAS: FCCC is funded by a grant from the Indiana Department of Corrections and authorized by Indiana statute, specifically IC 11-12-1-2.5 which states that Community Corrections programs "shall use evidence-based services, programs and practices that reduce the risk for recidivism among persons who participate in the community corrections programs" and

WHEREAS: it is in the best interest of both parties and the community to support the operation of Community Corrections programs, as an alternative to jail and a means of supervision, so we will minimize the risk to society while allowing individuals to work and continue with treatment programs, religious/peer/community support groups and cognitive behavioral programs and school while living in their own home or other safe and sober living environment,

NOW, THEREFORE, BE IT RESOLVED BY THE FLOYD COUNTY COUNCIL and the BOARD OF COMMISSIONERS OF FLOYD COUNTY, INDIANA, that: The Agreement for electronic monitoring for Community Corrections Programs between Floyd County Community Corrections Board and the Floyd County Sheriff has been voted on. The agreement has been passed and adopted by the Floyd County Council and the Board of Commissioners of Floyd County, Indiana

Pursuant to IC 36-1-7-6, the Agreement approved herein must be recorded with the Floyd County recorder before it takes effect. Not later than sixty (60) days after it takes effect, the Agreement must be filed with the state board of account for audit purposes.
