This Affidavit is valid for five years or as long as all of the conditions for an Active Farmer or Active Farming are met, whichever expires first.

If it is determined that the requirements of this Affidavit are not met, the Assessor's Office/Floyd County Stormwater Department Board can seek retroactive user fees based on the ERUs for up to three years.
