

FLOYD COUNTY ORDINANCE FCO 2023-44  
AN ORDINANCE ESTABLISHING RATES AND CHARGES FOR SERVICES  
RENDERED BY THE FLOYD COUNTY HEALTH DEPARTMENT

WHEREAS, the Board of Commissioners of the County of Floyd is empowered, pursuant to the provisions of I.C. 36-1-3, et seq., to establish reasonable rates, charges, and fees for governmental services provided to the public; and

WHEREAS, the Floyd County Health Department has requested the establishment of fees and charges for medical and regulatory services provided by the Department, as more particularly set forth in the Fee Schedules appended hereto and made a part hereof; and

WHEREAS, upon review, the Board of Commissioners of the County of Floyd has determined that the scheduled fees and charges do not exceed the administrative cost of those regulatory powers to be exercised or the cost of the services to be provided by the Department; and

WHEREAS the Board of Commissioners of the County of Floyd is desirous of adopting by this Ordinance the Schedule of Fees to be charged by the Department for services rendered.

NOW THEREFORE BE IT ORDAINED, that the fees and charges set forth on the Fee Schedule(s) appended hereto and incorporated herein be, and the same hereby are, adopted and established as the fees and charges to be levied and imposed for the various services to be rendered and performed by the Floyd County Health Department, with such fees and charges, upon collection and receipt, to be deposited by the Department as required by law.

BE IT FURTHER ORDAINED, that all previous ordinances adopted for the purpose of establishing rates and charges for services to be rendered and performed by the Floyd County Health Department be, that the same hereby are, repealed.





## **NURSING:**

**\*Cost of vaccine rates will vary upon market value; Health Department admin fee will remain constant\***

- Vaxcare Vaccine:
  - Cost of vaccine + admin fee set by Vaxcare
- VFC (Vaccines for children) supplied from Indiana Department of Health (vaccine provided at no cost to Health Dept)
  - \$12.00 Health Department admin fee
- 317 Vaccine supplied from Indiana Department of Health (vaccine provided at no cost to Health Dept)
  - \$12.00 Health Department admin fee
- County Purchased Vaccine
  - Cost of vaccine + \$12.00 Health Department admin fee
- TB Test
  - \$12.00 Health Department admin fee
  - TB Gold Test \$35.00
- Rabies IG & Prophylaxis (private pay)
  - Cost of vaccine + \$12.00 Health Department admin fee
- Rabies Vaccine (Pre-exposure- 2 dose series)
  - Cost of vaccine + \$12.00 admin fee

Per 16-41-19-2: All counties, cities, and towns shall supply without charge diphtheria, scarlet fever, and tetanus (lockjaw) antitoxin and rabies vaccine to persons financially unable to purchase the antitoxin or vaccine, upon the application of a licensed physician.

**NURSING (CONT.):**

- STI Screening/Meds (Insured or private pay)
  - Cost of treatment set by Indiana Department of Health + \$12.00 admin fee
  - Cost is free for persons financially unable to pay for treatment
  
- CPR Training (off-site)- \$160.00 + card
- CPR Training (on-site)- \$110.00 + card
  
- Pregnancy Test- \$12.00 admin fee
  - If pregnant, admin fee includes presumptive eligibility, prenatal vitamins, and doctor referral.
  - Cost is free for persons financially unable to pay for test
  
- Lead Test- \$3.00
