THE EMPLOYEE DIDN'T SHARE DETAILS ABOUT THEIR ILLNESS UNTIL 6/29 AND WAS SENT HOME AS SOON AS THEY REPORTED VOMITING. KELLY (HR MANAGER) CONFIRMED THE STATEMENT GREG MADE AND WAS THE REPORTING MANAGER WHO SPOKE WITH THE SICK EMPLOYEE. THE SICK EMPLOYEE IS ON LEAVE UNTIL 24 HOURS AFTER THEIR FEVER IS GONE, PER CDC GUIDELINES.</p> <p>THE ILLNESS POLICY WAS REVIEWED AND WAS FOUND TO BE COMPLIANT WITH IDOH REQUIREMENTS. THERE IS CURRENTLY NO EVIDENCE THAT THE ILLNESS POLICY WAS NOT ADHERED TO, HOWEVER KELLY (HR MANAGER) AND THE ILL EMPLOYEE ARE TO REVIEW AND SIGN A COPY OF THE ILLNESS POLICY TO ENSURE THAT INVOLVED EMPLOYEES ARE FAMILIAR WITH THE POLICY.</p>
