Dale moved to approve the minutes from 3-1-17. Seconded by Tony. Motion carried.

Tom presented the Treasurers report. There were three expenditures since the last LEPC meeting. The current balance is \$50,993.78 with a projected balance of \$54,958.32 (pending HMEP grant reimbursement). Andy moved to approve the report. Seconded by David. Motion carried.

Tom stated the State requires that an exercise proposal be submitted by March 1. He has submitted that proposal. He added that all of the requirements for LEPC have been submitted.

Tom stated Steve Comer, farmer, reported a spill of anhydrous ammonia. He stated that his tractor collided with a mobile tank and leaked an unreported amount of ammonia gas.
