

Please use a black or blue ink pen to mark your ballot. To vote for your choice in each contest, completely fill in the box next to your choice.

(1) You are not required to vote a straight party ticket. If you do not wish to vote a straight party ticket, do not make a mark in this section, and proceed to voting the ballot by office.

(2) To vote a straight Republican, Democratic, Libertarian, or We the People ticket for all Republican, Democratic, Libertarian, or We the People candidates on this ballot, except for candidates described in (3) below, make a voting mark on or in this box and do not make any other marks on this ballot.

(3) To vote for any candidate for a COUNTY or TOWN COUNCIL MEMBER AT-LARGE, you must make another voting mark for each candidate you wish to vote for. Your straight party vote will not count as a vote for any candidate for that office.

(4) If you wish to vote for a candidate seeking a nonpartisan office or on a public question, you must make another voting mark on the appropriate place on this ballot.


(5) A write-in vote will NOT be counted unless the vote is for a DECLARED write-in candidate. To vote for a write-in candidate, you must make a voting mark on or in the square to the left of the name you have written in or your vote will not be counted.


(6) A ballot cast for candidates for President and Vice President are votes cast for electors and alternate electors pledged to support the candidates according to IC 3-10-4-3.
