CONSTITUTIONAL AMENDMENT NUMBER 1

That Section 1 of Article 12 of the Constitution of the State of Indiana be amended to read as follows: Section 1. The militia shall consist of all able-bodied maile persons, between the ages of eighteen and forty-five years, except such as may be exempted by the laws of the United States, or of this state; and shall be organized, officered, armed, equipped and trained, in such manner as may be provided by law.
