**INSTRUCTIONS:** This form is used by a nominee chosen in a primary, nominated by petition, or chosen by a convention who wishes to remove the nominee's name from the general election ballot. This form is also used by a write-in candidate who wishes to withdraw.

**DEADLINE:** Except as otherwise provided by law, this withdrawal must be received by the official with whom the Declaration of Candidacy or Petition of Nomination was filed (*circuit court clerk or the Indiana Election Division*) by NOON, July 15, 2026, if **nominated at the primary election, party convention, or by petition of nomination**. A write-in candidate (for an office other than school board) must file this form by NOON, July 15, 2026.

**For School Board offices:** A school board candidate must file this form by NOON, July 15, 2026. A write-in candidate for school board office must file this form by NOON, August 24, 2026.

**For Small Town offices:** A candidate who files a declaration of candidacy for a town office in a town with a population of less than 3,500 may withdraw by filing this statement by NOON, August 3, 2026. A candidate nominated by a town convention must file this withdrawal with the circuit court clerk no later than NOON, three (3) days after the adjournment of the town convention. A candidate for city or town office in a municipal election year (such as 2027) uses the CAN-46 form to withdraw.
