

HOWARD COUNTY COUNCIL REGULAR MEETING MARCH 22, 2016

The Howard County Council met in Regular Session on Tuesday, March 22, 2016, at 4:00 p.m. in Hearing Room 337 of the Administration Center. Those in attendance included President Richard Miller, Vice President Jim Papacek, and members Stan Ortman, Leslie Ellison, John Roberts, and Dwight Singer. Also in attendance were County Attorney Larry Murrell and Auditor Martha Lake.

The meeting was called to order by Sheriff Steve Rogers and conducted by Council President Richard Miller. Vice President James Papacek led in the Pledge of Allegiance and President Miller offered a word of prayer.

At this time a word of silence was observed for the family of fallen Officer, Deputy Carl Koontz, and for injured Sergeant Jordan Buckley and his family. This was done in recognition of service and sacrifice of both Officer Koontz and Officer Buckley for the citizens of Howard County.

Sheriff Steve Rogers took this opportunity to say a few words to those in attendance. On behalf of all the Law Enforcement members of Howard County he thanked those who have shown support and offered encouragement from all of the State of Indiana, our nation, and especially the citizens of Howard County. This has been the "bright spot" in such a terrible tragedy.

IN THE MATTER OF APPROVAL OF MINUTES:

Auditor Martha Lake submitted the Special Meeting minutes dated March 3, 2016 and the Regular Meeting Minutes dated February 23, 2016. A motion was made by Mr. Papacek to approve the Special Meeting minutes as submitted. The motion was seconded by Mr. Ortman and carried.

A motion was made by Mr. Ortman, seconded by Mr. Singer and carried to approve the Regular Meeting minutes dated February 23, 2016 as submitted.

Howard County Clerk Kim Wilson spoke to the County General request and to the Clerk's Perpetuation Request. Sheriff Steve Rogers is requesting additional funds in order to purchase nineteen Stainless Steel tables for the Criminal Justice Center. The current tables are made of wood fiberboard covered with Formica and are original to the facility. They no longer meet safety requirements of acceptable equipment for the Center, as they have the potential to house infections. The results of past Jail Inspections have listed replacing the tables as a recommendation, but the outbreak of jailhouse infections have pushed the issue to the forefront and was written as a recommendation on the most recent jail inspection.

A motion was made by Mr. Ortman to approve the request of \$12,220.75 to line item 04721.00, Equipment. The motion was seconded by Mr. Ellison and carried.

Commissioner Wyman reminded the Council members that this request was originally submitted at the February Council meeting, and tabled, giving the Council members more time to review the increase to the Security Officer position. He reviewed the request and asked that it be taken off the table for consideration.

Mr. Papacek made a motion to remove the Superior Court II transfer requests off the table. The motion was seconded by Mr. Roberts and carried.

Mr. Wyman then requested that the transfer requests be approved. After commending Mr. Wyman on the work he does for the County, Mr. Roberts suggested that several adjustments to the Security Officer line item be made before the Council addresses all three of the requests. IN THE MATTER OF THE UPDATE ON THE REVOLVING LOAN FUND:

Howard County Surveyor Dave Duncan updated the County Council on the EDIT Revolving Loan Fund that is currently being used to repair damaged drains in Howard County. He reminded the Council that the original \$1.2 million from the EDIT Fund was made available in 2013 to expedite much needed repairs for eight (8) county regulated drains. The property taxes for the land the drains were located on would pay higher assessment rates until 2018, when the loan will be repaid to the EDIT Fund. To date the County has received \$1,057,440.00 to be applied to the loan. Mr. Duncan would like to keep this in the Drainage Fund until December 31, 2018, but it is available should the County request it. Mr. Duncan thanked the Board of Commissioners and the County Council for their "out-of-the-box thinking". The Surveyor's Office continues to receive phone calls from residential landowners and agricultural farmers thanking the county for the much needed repairs, and for being able to shorten the length of the higher assessments.
