

HOWARD COUNTY COUNCIL REGULAR MEETING NOVEMBER 26, 2013

The Howard County Council met in Regular Session on Tuesday, November 26, 2013, at 4:00 p.m. in Hearing Room 338 of the Administration Center. Those in attendance included President Richard Miller, Vice President Stan Ortman, and Members Jeff Stout, Leslie Ellison, John Roberts and James Papacek. Also in attendance were County Attorney Larry Murrell and Auditor Martha Lake.

Before the meeting was called to order and in the spirit of the Thanksgiving Season, President Miller offered a word of prayer. The meeting was called to order by Sheriff Steve Rogers and conducted by President Richard Miller.

IN THE MATTER OF THE APPROVAL OF MINUTES:

The minutes of the October 22, 2013 meeting, having been previously submitted and reviewed, were approved on a motion made by Mr. Stout and seconded by Mr. Papacek.

IN THE MATTER OF COUNCIL COMMENT:

President Miller opened the floor for Council comment as follows:

Councilman Jim Papacek: Mr. Papacek thanked the employees of Howard County, and especially those in the Sheriff and Dispatch Departments, the Emergency Management Agency, and the Highway Department for all the work they did for all the citizens of Howard County during our recent storms and tornados.

Public Defender Steve Raquet explained that the Full Time Deputy Public Defender being paid from 01113.31 has retired. That position will not be replaced. He would like to transfer the remainder of the fund to 01113.30 to take four part-time Deputy Public Defenders to full time so that their work load can be increased. This brings his office in line with his 2014 budget requests.

Judge Menges also reviewed all the Assistant positions as follows: Mr. Christopher Biehn will be elevated from Juvenile Probation Officer to Assistant Chief Probation Officer, Juvenile Probation; Mr. Chuck McCloskey is the Assistant Probation Officer, Drug & Alcohol; and Ms. Debra Bernard is the Assistant Adult Probation Officer. Mr. Delong then took the floor to explain the transfer request and he was congratulated by Council President Richard Miller. Before addressing the transfer request, Mr. Delong was asked to greet each Council member for introduction and congratulations. The Sheriff's Department experienced the loss of several corrections officers to Chrysler so the part time officers have had to fill in the places. The nursing line items reflect the increase in population as well as an increase in medical transports for procedures at the hospital, and five in patient and five out-patient surgeries. We currently have three full time nurses and two part time nurses working around the clock to meet the medical needs of the inmates.

A motion was made by Mr. Ortman to approve the transfer requests as submitted. The motion was seconded by Mr. Papacek and carried.

Salary Ordinance No. 2013-HCCO-33 – Amending Salary Ordinance for 2013 was approved on a motion made by Mr. Papacek and seconded by Mr. Ellison.

IN THE MATTER OF SHERIFF DEPARTMENT ISSUES:

1) On October 31, 2013, Sheriff Steve Rogers received a letter from First Farmers Bank informing the Sheriff that they were terminating their service to us regarding the Howard County Police Benefit Plan Trust and the Howard County Police Retirement Plan Trust. Options were discussed between Sheriff Rogers and Mr. Douglas concerning possible options. Mr. Douglas recommended Mutual Bank in St. Joe County. On November 19, 2013, Sheriff Rogers received a communication from Mutual Bank confirming that they would be able to provide the service. The administration fee will be .2% (\$24,638.73) of the total assessed value of the plan (\$12,319,364.00). Sheriff Rogers has informed the Merit Board of this decision, as well as Mr. Ron Metz. It was their consensus that the plan was being run very well. Sheriff Rogers will make sure the Auditor's Office has the new routing information. A motion was made by Mr. Ortman to authorize President Miller to approve the transfer. The motion was seconded by Mr. Papacek and carried.

2) Sheriff Rogers submitted the October, 2013, Jail Commissary Fund and reviewed it with the Council Members. The balance as of October 31, 2013, was \$161,630.02. Sheriff Rogers also apprised the County Council of the activities of the Sheriff's Department and the 911 Dispatch Center during and after the storms and tornados on November 17, 2013.

IN THE MATTER OF PUBLIC COMMENT:

President Miller opened the floor for public comment as follows:

Grace Aprill, 12765 East County Road 100 N, Greentown, Indiana; Ms. Aprill distributed copies of a prepared statement concerning the Amended Economic Development Agreement and the Amended SB-1 of the Wildcat Wind Farm II, LLC. The statement also voiced health and safety concerns as they apply to industrial wind turbines.

IN THE MATTER OF AUDITOR ISSUES:

Auditor Lake submitted the 2014 Council Meeting Schedule for the Council members' review.

Ms. Lake submitted Form 1782 Notice, Budget Year 2014, The Notice of Final Budget Recommendations, and reviewed several financial and budgeting matters.

Concerning the 2014 Salary Ordinance, some of the language pertaining to several positions, approved for the 2014 budget year, need to be changed in order to comply with the requirements of the Affordable Health Care Act. A motion was made by Mr. Papacek to authorize Auditor Lake to make necessary changes in the 2014 Salary Ordinance in order to comply with the Affordable Health Care Act. The motion was seconded by Mr. Roberts and carried.

Ms. Lake was asked to speak at a local League of Women Voters meeting and she distributed copies of a power point presentation to the council members, concerning county offices and their official duties.

IN THE MATTER OF VETERANS SERVICE OFFICE CONCERNS:

Veterans Service Officer, Retired Colonel Ross Waltemath reviewed his October Monthly report with the Council members and field questions concerning the new construction of Jackson Street Commons, on the corner Jackson Street and Apperson Way, specifically for displaced veterans. The building will have twenty-six (26) units with 4-6 units designed for couples and the remainder as single units. Mr. Waltemath will help with reviewing and confirming applications for occupancy. There are plans to open in February, 2014.
