Thank you for requesting broadcast coverage of a Jennings County trial court proceeding. Upon receipt of your request, the judge will provide a copy of the request to the counsel of record and parties appearing without counsel.

Requests to broadcast court proceedings shall be submitted at least five (5) business days prior to the proceedings. If media are unable to submit the request with more than five (5) business days prior to the proceedings, indicate an expedited review of the application and the reason. The Court will work to review expedited requests but cannot guarantee review.

Each request will be carefully considered, and the Court will inform the requestor whether it has been denied or granted, and what conditions may apply. For example, the judge may require media to use a pool camera, and media will be required to work out the details with their fellow journalists.

All requests granted may be withdrawn at the sole discretion of the judge.
