

NOTICE OF COUNTY OPTION INCOME
TAX ORDINANCE VOTE

The County Council of the County of Martin hereby declares that on March 25, 1991 at 9:00 A.M., a public hearing will be held at the Martin County Courthouse, Shoals, Indiana, concerning the following resolution to propose an ordinance and the proposed ordinance that is before the members of the county income tax council. MINUTES OF THE COUNTY OPTION INCOME TAX COUNCIL

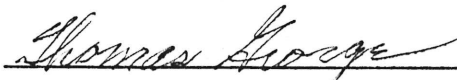
The Martin County Option Income Tax Council met in the Commissioners Room of the Martin County Courthouse, Shoals, Indiana, at 9:00 AM on the 25th day of March, 1991, which date and time being the date and time hereto set for this meeting, notice of which meeting was duly published in the Loogootee Tribune and the Shoals News. Thomas George acted as Chairman.

The only item of business before this meeting was the County Economic Income Tax adoption as proposed by the Martin County Council. Since no report was received from the Common Council of the City of Loogootee, the Town Board of Crane, or the Town Board of Shoals, under Indiana law this is reported as a negative vote for the adoption of the County Economic Development Income Tax. With this taken into account the vote for the adoption of the County Economic Development Income Tax is 61.88% in favor, and 38.12% voting against. The report of such vote is as follows:
