AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF
MARTIN COUNTY, INDIANA VACATING A PUBLIC WAY
IN MARTIN COUNTY, INDIANA

WHEREAS, Philip R. Baker filed with the Board of Commissioners of Martin County, Indiana, a petition for the vacation of a part of a certain public roadway located in Center Township in Martin County, Indiana, more particularly described as:

County Road 19 from a point 352 feet North of the point of intersection of County Road 19 and the South line of Section 5, Township 3 North, Range 3 West, thence Northerly until its intersection with the South bank of the East Fork of the White River.

WHEREAS, notice of this petition and of the time and place of hearing thereon was published, in the manner prescribed by I.C. 5-3-1, in the Loogootee Tribune on June 29, 1995 and in the Shoals News on June 28, 1995, two newspapers of general circulation in Martin County, Indiana; and

WHEREAS, all owners of land abutting the property proposed to be vacated have joined in the petition or have consented to this petition, and

WHEREAS, at the hearing on this matter before the Board of Commissioners of Martin County, Indiana, held the 29th day of July, 1995, said Board found as follows:

1. Philip R. Baker, Oscar A. Baker and Virginia Baker are the owners of all the real property which is contiguous to that part of the roadway sought to be vacated and being a roadway as described hereinabove in Section 5, Township 3 North, Range 3 West in Center Township, Martin County, Indiana.

2. Said roadway is a public highway located entirely within Martin County, Indiana.

3. The vacation of said public highway or part thereof described as:

County Road 19 from a point 352 feet North of the point of intersection of County Road 19 and the South line of Section 5, Township 3 North, Range 3 West, thence Northerly until its intersection with the South bank of the East Fork of the White River.

is in the best interests of the Petitioners and of Martin County, Indiana.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MARTIN COUNTY, INDIANA:

SECTION 1.

That on or after the passage of this Ordinance, that part of a roadway located in Center Township, Martin County, Indiana, described as:

County Road 19 from a point 352 feet North of the point of intersection of County Road 19 and the South line of Section 5, Township 3 North, Range 3 West, thence Northerly until its intersection with the South bank of the East Fork of the White River.

is vacated as a public highway and right of way for Martin County, Indiana.

SECTION 2.

All prior ordinances passed and adopted which are in conflict with this Ordinance are repealed to the extent of any such conflict.

SECTION 3.

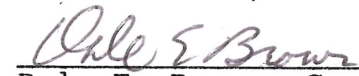
This ordinance shall be in full force and effect from and after its passage according to law.

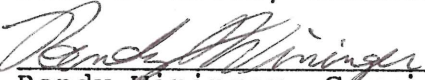

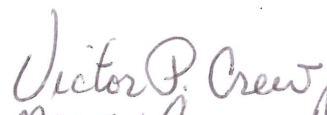
