AN ORDINANCE OF THE BOARD OF COMMISSIONERS ORDER MARTIN COUNTY
MARTIN COUNTY, INDIANA VACATING A PUBLIC WAY
IN MARTIN COUNTY, INDIANA

WHEREAS, Jerald Harner filed with the Board of Commissioners of Martin County, Indiana, a petition for the vacation of a part of a certain public roadway located in Center Township and Lost River Township in Martin County, Indiana, more particularly described as:

County Road 184 from its intersection with County Road 9 in Section 15, Township 2 North, Range 4 West to the East line of the Northwest quarter of the Northwest quarter of Section 23, Township 2 North, Range 4 West, and continuing to its intersection with County Road 182.

WHEREAS, notice of this petition and of the time and place of hearing thereon was published, in the manner prescribed by I.C. 5-3-1, in the Loogootee Tribune on October 24, 1996 and in the Shoals News on October 30, 1996, two newspapers of general circulation in Martin County, Indiana; and

WHEREAS, all owners of land abutting the road proposed to be vacated have been given notice of the petition and have verbally consented to this petition, and

WHEREAS, at the hearing on this matter before the Board of Commissioners of Martin County, Indiana, held the 23rd day of November, 1996, said Board found as follows:

1. That United States of America, James Troutman, Bonnie Troutman, Luther Fuhrman, Theresa Fuhrman, Jerald Harner and Beverly Harner are the owners of all the real property which is contiguous to that part of the roadway sought to be vacated and being a roadway as described hereinabove in Center Township and Lost River Township, Martin County, Indiana.

2. That said roadway is a public highway located entirely within Martin County, Indiana.

3. The vacation of said public highway or part thereof described as:

County Road 184 from its intersection with County Road 9 in Section 15, Township 2 North, Range 4 West to the East line of the Northwest quarter of the Northwest quarter of Section 23, Township 2 North, Range 4 West, and continuing to its intersection with County Road 182.

is in the best interests of the Petitioners and of Martin County, Indiana.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MARTIN COUNTY, INDIANA:

SECTION 1.

That on or after the passage of this Ordinance, that part of a roadway located in Center Township and Lost River Township, Martin County, Indiana, described as:

County Road 184 from its intersection with County Road 9 in Section 15, Township 2 North, Range 4 West to the East line of the Northwest quarter of the Northwest quarter of Section 23, Township 2 North, Range 4 West, and continuing to its intersection with County Road 182.

is vacated as a public highway and right of way for Martin County, Indiana.

SECTION 2.

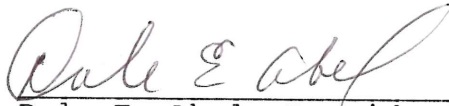
All prior ordinances passed and adopted which are in conflict with this Ordinance are repealed to the extent of any such conflict.

SECTION 3.

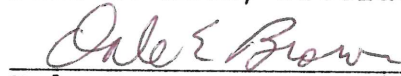
This ordinance shall be in full force and effect from and after its passage according to law.

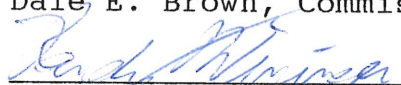

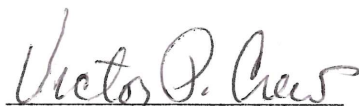
