

ORDINANCE NO. 1998-1

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF
MARTIN COUNTY, INDIANA VACATING A PUBLIC WAY
IN MARTIN COUNTY, INDIANA

WHEREAS, Steven J. Baker and Lisa J. Baker filed with the Board of Commissioners of Martin County, Indiana, a petition for the vacation of a part of a certain public roadway located in the Town of West Harrisonville, now Trinity Springs, Mitchelltree Township, Martin County, Indiana, more particularly described as:

All of the public roadway that lies between Lots 5 and 6 in West Harrisonville, now Trinity Springs, Indiana.

WHEREAS, notice of this petition and of the time and place of hearing thereon was published, in the manner prescribed by I.C. 5-3-1, in the Shoals News on December 24, 1997 and in the Loogootee Tribune on January 1, 1998 two newspapers of general circulation in Martin County, Indiana; and

WHEREAS, all owners of land abutting the property proposed to be vacated have joined in the petition or have consented to this petition, and

WHEREAS, at the hearing on this matter before the Board of Commissioners of Martin County, Indiana, held the 16th day of Janaury, 1998, said Board found as follows:

1. Steven J. Baker and Lisa J. Baker are the owners of all the real property which is contiguous to that part of the roadway sought to be vacated and being all that part of the public way that lies between Lots 5 and 6 in West Harrisonville, now Trinity Springs, Martin County, Indiana.

2. Said roadway is a public highway located entirely within Martin County, Indiana.

3. The vacation of said public highway or part thereof described as:

All that part of the public way that lies between Lots 5 and 6 in West Harrisonville, now Trinity Springs, Martin County, Indiana.

is in the best interests of the Petitioners and of Martin County, Indiana.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MARTIN COUNTY, INDIANA:

SECTION 1.

That on or after the passage of this Ordinance, that part of a roadway located in Mitchelltree Township, Martin County, Indiana, described as:

All that part of the public way that lies between Lots 5 and 6 in West Harrisonville, now Trinity Springs, Martin County, Indiana.

is vacated as a public highway and right of way for Martin County, Indiana.

SECTION 2.

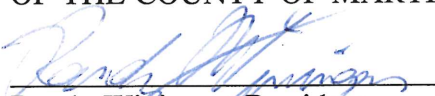
All prior ordinances passed and adopted which are in conflict with this Ordinance are repealed to the extent of any such conflict.

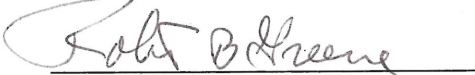
SECTION 3.

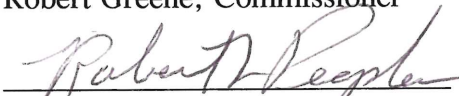
This ordinance shall be in full force and effect from and after its passage according to law.

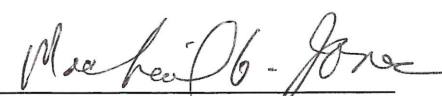
