ESTABLISHING BOARD OF COMMISSIONER MEETINGS FOR THE YEAR 2000

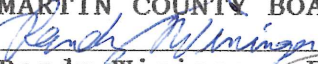

SCHEDULE OF CLAIMS

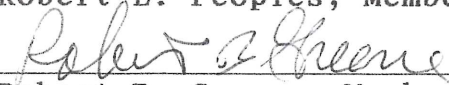

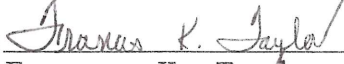
