) PRECINCT ESTABLISHMENT ORDER

WHEREAS, pursuant to IC 3-11-1.5-14, the Boards of Commissioners of the counties identified herein submitted proposed precinct establishment orders to the co-directors of the Indiana Election Division;

WHEREAS, pursuant to IC 3-11-1.5-17 employees designated by the co-directors, and employees of the Office of Census Data, have examined the proposed precinct establishment orders and have reported to the Indiana Election Commission that the proposed precinct establishment orders comply with the standards set forth in IC 3-11-1.5;

WHEREAS, the co-directors of the Indiana Election Division have advised the Boards of Commissioners of said counties, and have advised the Indiana Election Commission, that they recommend that the Indiana Election Commission approve the proposed precinct establishment orders based upon each order's compliance with the standards set forth in IC 3-11-1.5;

IT IS THEREFORE ORDERED:

SECTION 1. The Indiana Election Commission, in accordance with I.C. 3-11-1.5, approves the proposed precinct establishment orders for the precincts in the following counties:

Hendricks, Delaware, Martin, Putnam, Carroll, Pulaski, and Daviess

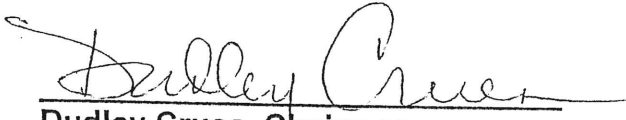
SECTION 2. A copy of the precinct summary statement (State Form 13332; IEC-8), a legal description and a map for each precinct approved under SECTION 1 is incorporated by reference in this ORDER.

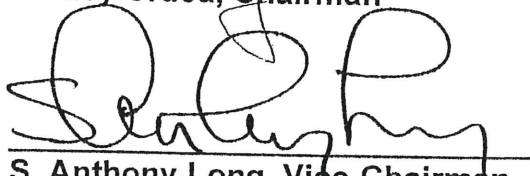
SECTION 3. The Election Division shall provide a copy of this ORDER to the County Commissioners, as county executive, of each county listed in SECTION 1. Under I.C. 3-11-1.5-22, the County Commissioners may then issue their precinct establishment order. The County Commissioners shall file a copy of the final precinct establishment order and the legal notice concerning the order with the Indiana Election Division, in accordance with IC 3-11-1.5-23 and IC 3-11-1.5-29(2). The Indiana Election Division shall file a copy of the final precinct establishment order with the Office of Census Data in accordance with IC 3-11-1.5-23.

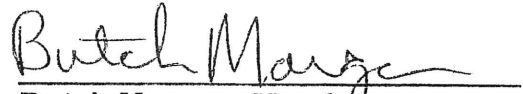
SECTION 4. This ORDER is effective October 25, 2001, the date the proposed precinct establishment orders were approved by unanimous vote of the Commission.

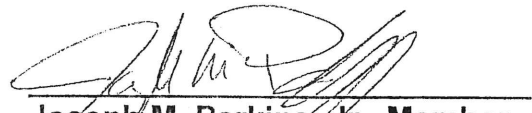
