WHEREAS, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual budget; Now, therefore:

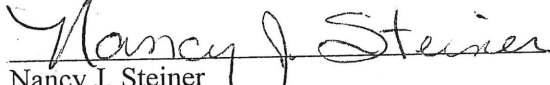

Once appropriated I can transfer it to the Redevelopment Commission and there will have to be another additional appropriation done.
