

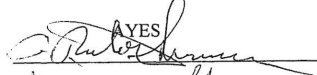
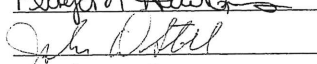
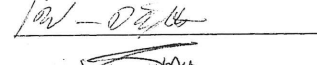
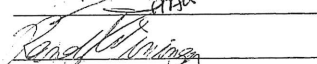
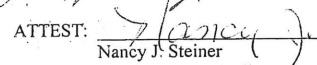
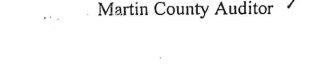
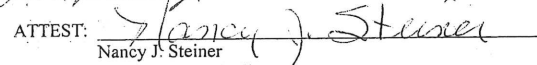
ADDITIONAL APPROPRIATION ORDINANCE

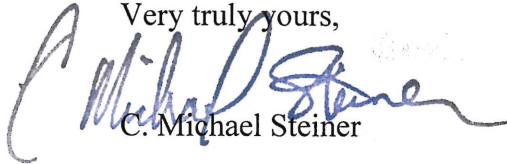

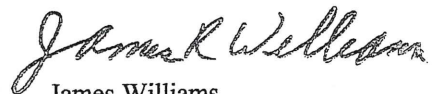

We will need to do an additional appropriation out of EDIT for the 25% pledge to redevelopment. The county will receive \$276,910 in EDIT distribution this year so 25% of that is \$69,228. You will need to do the additional out of County EDIT and then we will have to do an additional in the Bond Principal & Interest account for Redevelopment for \$546,850. They budgeted it in the Capital Fund and it should have been budgeted in the Bond and Interest.

Also when we do budgets for 2011 we need to include this in the budget process so that we don't have to do an additional every year.
